Mayor Herbst & City Councilmembers:

Last Tuesday was an exciting day as we enjoyed our annual Youth In Government (YIG) Day with high school students from Vandalia-Butler School District who were paired with senior city leaders and Council members to learn about local government. We enjoyed having the students attend a city staff meeting and several of them participate in a simulated Council Study Session and Council Meeting. This annual event has been a great way for City, Township, and School District leaders to partner with high school students to share insight into how various local government entities work to provide quality services and education to our community. A special "thanks" to Gabrielle "Gabby" Holop who served as my counterpart as city manager for the day and learned about overseeing and managing city operations. I also want to thank Ben Graham and Mike Hammes for their assistance in coordinating the students with their city counterparts and preparing the materials for the simulated Council meeting. Thank you to Julie Trick and the Vandalia-Butler Optimist Club for organizing this event and coordinating the lunch at the high school banquet room for the students and local government officials who participated in YIG. Special thanks to the local credit unions who supported YIG Day by covering the lunch costs. This is always a special annual event that we hope inspires young people to consider opportunities to serve their community.

The tax office survived another successful tax season! Between March 31, 2025, and April 15, 2025, the Finance Department assisted 1,590 taxpayers at the counter, received 754 phone calls, 450 emails, and 3,075 electronic tax returns (January through April). Great job by our Finance Department employees for their diligence and commitment during tax season!

On Thursday, April 17th, the Division of Fire and Division of Police participated in a mock crash at the high school. The mock crash is held to bring awareness to teens about the dangers of impaired and distracted driving. The event is typically presented during the week of prom and involves the Vandalia Butler Schools, Vandalia and Butler Twp. Fire Departments, Vandalia and



Butler Twp. Police Departments, Care Flight, and Morton Whetstone Funeral Home. This year, all high school grades were able to watch and participate in the event. A special thanks to the Public Works Department for assisting with staging the "wrecked" vehicles for the mock crash.

On April 23rd, the Dayton International Airport held the 2025 Annual Emergency Plan Review Triennial Full-Scale Exercise involving a simulated plane crash. The Vandalia Division of Fire participated in this exercise by sending equipment and crews to participate in this event since they work closely with neighboring departments, including the airport. The Division of Police also participated by having a police officer involved in the exercise drill.

Public Safety Telecommunicators Week was April 13-19th and gave us the opportunity to recognize the great work that our dispatchers do 24/7. Our public safety specialists (PSS) fill a crucial role in answering all 911 and non-emergency calls in the Communications Center and dispatching police, fire, and EMS crews to calls for service as well as providing information to citizens who either visit or call the Comm Center with questions. Our PSS are a dedicated group of employees who we were able to thank and highlight individually on social media throughout the week. Thanks to all our PSS for their outstanding work!!

On Saturday, April 19, we hosted our Annual Vandalia Easter Eggstravaganza at the Sports Complex, with over 1,000 attendees. The event featured two egg hunts, one at 11:00 am and another at 12:30 pm, for children ages 12 and under. Families also enjoyed face painting, balloon animals, games, crafts, local vendors, food trucks, and photo opportunities with the Easter Bunny!

The Vandalia Parks and Recreation Department was awarded a grant from the Dayton Foundation for \$3,650 to purchase supplies for the Mobile Sensory Tent. This tent area will be for those with sensory sensitivities and will be available at special events and recreation initiatives. Congratulations and thanks to our VRC staff for putting the work into applying for and receiving this grant to offer this special amenity.

The City of Vandalia Annual Arbor Day Celebration event was held today at Morton Middle School. A Crimson Sunset Maple tree was planted on the school grounds with the sixth-grade class attending the event and assisting with the tree planting. Each student received a White Flowering Dogwood seedling to take home for planting.

The Division of Fire is happy to have Jacob Walters return home to the Fire Dept. family and back in his role as a Full-Time Firefighter/Paramedic. Jacob was sworn in at the Monday, April 21st council meeting with his family and will be assigned to C-shift. Congrats and welcome back Jacob!

Captain Walker continues to attend critical operations planning meetings for the upcoming NATO Parliamentary Assembly scheduled in Dayton, May 21-26, 2025. Dayton Police Department has requested mutual aid from all police agencies across Ohio, and VPD will provide manpower assistance with security posts.



During the past five weeks, VPD officers made 14 traffic stops on commercial motor vehicles for traffic violations. These stops resulted in two traffic citations and seven written warnings, and one verbal warning while working 12 additional enforcement hours. Officers issued four verbal warnings during regular patrol.

This week, the Ohio Department of Transportation (ODOT) released the Transportation Review Advisory Council (TRAC)'s list of funded projects for this current round of funding. The DIA Logistics project was selected to receive \$2,000,000 in federal funding towards right of way and utility relocation work. (See attached announcement.) We have already received \$1,600,000 for engineering. A final submission will be for 80% of the construction costs. This project is scheduled to begin later this year with right-of-acquisition and construction completed by 2028.

On Wednesday, April 23rd, we honored our Administrative Professionals who serve in the City Manager's Office and in the various city departments. We thank each of them for their dedicated service and their contributions to ensure operations and tasks are completed efficiently and professionally. Great job to our Administrative Professionals!

Congratulations to City Planner Ben Graham and his wife Morgan on the recent birth of their daughter on March 31st. They welcomed a beautiful baby girl, Melanie Marie Graham, and they are home and doing well.

Parks & Recreation Director Steve Clark has notified me of his intent to retire on July 7, 2025. Steve has 37 years of dedicated service to Vandalia and has provided exceptional service in his role as Parks & Recreation Director. Steve's final workday will be Friday, June 13th, which coincides with his first day of work on June 13, 1988. Congratulations Steve on a job well done and we wish you the best as you move into the phase of life.

Our Council Retreat is scheduled for Monday, July 7th from 4:00-7:00 pm in the Justice Center's Community Room. We will cover an array of relevant topics on city projects and initiatives and provide food during the meeting. As the date nears, I will provide Council and staff with an agenda of topics that we plan to cover.

I want to thank Council, senior staff, the Police Division employees, community members, and colleagues from various law enforcement agencies who gathered today at the Justice Center for my retirement celebration. It has been an honor to be a member of the Police Division for the past 10 ½ years and serve as police chief for the past seven years. My retirement from the Police Division marks the end of 33 years of service in policing, serving at Englewood Police Department, Montgomery County Sheriff's Office, and Vandalia Division of Police. I have been blessed to work with many wonderful professionals who serve selflessly to protect their communities. I wish them the best and pray for their safety. I look forward to the next chapter as I move into the city manager role full-time on May 1st.

Re: Information Update for April 12 - 25, 2025

- The highlight of this reporting period was Youth in Government Day. This is always a great day to spend time with the Vandalia Butler High School students and share some of the behind-the-scenes operations of local government. I had the pleasure of spending the morning with Alyssa Neth, who was Assistant City Manager for the day. Also, a big thank you to the Optimists Club for organizing the day and our local Credit Unions for sponsoring the lunch. Kudos to Ben Grahm and Mike Hammes for putting together the agenda for the day an assisting with the mock council meetings.
- You and I met last week with an existing local business inquiring about their expansion and the possibility of the site at 10 W. National Road in the future.
- Ben Borton and I attended a joint meeting of the Montgomery County and Miami County Commissioners for the presentation and hearing for the DIA Logistics Roadway project on Tuesday April 15th. The main topic for the hearing was regarding the property acquisition required to build the project. The hearing is required to allow the public the opportunity to speak about the project. At the close of the hearing the commissioners from both counties approved moving forward with the acquisition process.
- Ben Borton and I also participated in the monthly progress meeting for the DIA Logistics Roadway project. Representatives from Montgomery County Engineer's Office, and the design team from Carpenter Marty discussed the progress on the design phase. Currently the team is finalizing the drainage design.
- ODOT just released the Transportation Review Advisory Council (TRAC)'s list of funded projects for this current round of funding. The DIA Logistics project was selected to receive \$2,000,000 in federal funding towards right of way and utility relocation work. See attached announcement. We have already received \$1,600,000 for engineering. A final submission will be for 80% of the construction costs.
- You and I attended the monthly Tri Cities Wastewater Authority board meeting this Wednesday. Work progresses and the Equalization Tank project. The concrete bases have been poured for both tanks. The design team is working on the 60% drawing for the new treatment plant and TCA is now advertising for bids for the sewer realignment project that will reroute a portion of Huber Heights sewer to the plant to eliminate long standing capacity issues with one of the current lines.

- I attended the Surveyors Workshop held at Ohio Northern University as part of my continuing education requirements for my Profession Surveyor License this week.
- I attended the I70/75 Development Association monthly meeting at Sinclair Community College this week. Karen Hesser from Five River Metro Parks was the presenter this month, giving an update on their 16,000 acres of recreational and conservation property.
- I attended the first Dayton Area Managers Association meeting for 2025. At this meeting, we discussed the current format of the meetings and how they will be facilitated moving forward regarding logistics and expenses.
- The Board of Zoning Appeals met on April 9th to consider a variance at 221 North American Boulevard for the total accessory structure area. They will have a meeting on May 14th to consider minimum lot frontage on the property being developed as "The Landing" at 650 Pool Avenue.
- Planning Commission will meet on May 13th to consider a rezoning at 3320 Benchwood Road from Residential Singel Family (RSF-1) to Highway Business (HB). 3320 is the last remaining residentially zoned property on Benchwood Road.
- Mike Hammes met with EJP Consulting Group. EJP is working on the upcoming Strategic Plan for Greater Dayton Premier Management. Topics included affordable housing, voucher programs and other similar issues.
- The next taping of Focus Vandalia was filmed this week. Topics for the May editions are Sweet Treats Festival, new Municity Connect software in DES, the Amphitheatre Ribbon Cutting and the introduction of Brandon Sucher, as our new Police Chief.
- The Garage Sale Weekend registration is live on our website and residents are beginning to get their sales registered.
- Information has been posted to our website and social media about our annual Shred Day that will be held Friday, May 16th from 9:00 to noon at the Municipal Building parking lot. Staff from all departments will be volunteering to assist our residents with their documents to be shredded.

1. Ohio Ethic's Commission: What's the scoop on hiring family members? The Ohio Ethics Law prohibits public officials and employees from hiring their family members. Prohibited activities include directly hiring a family member, indirectly influencing the hiring process, supervising a family member after hiring, or even participating in annual evaluations or participation in discussions of promotions or raises.

What might be new information, however, is the Ethics Commission's revised definition of "family." At its February 2025 meeting, Formal Advisory Opinion 2025-01 was approved and includes domestic partnerships where someone is living with a public official or employee as "family" for purposes of the Ohio Ethics Law.

To make this determination, the Commission reviewed how other Ohio agencies and courts have considered the issue and concluded this opinion is consistent with many state and local agencies that have included domestic partnerships in their family-related internal policies. As a result of this advisory opinion, for purposes of the Ohio Ethics Law, a "family member" now includes the following:

- Spouse
- Domestic Partner
- Children/Stepchildren (whether dependent or not and regardless of where they live)
- Siblings (regardless of where they live)
- Parents/Stepparents (regardless of where they live)
- Grandparents (regardless of where they live)
- Grandchildren (regardless of where they live)

"Family member" also includes any other person related by blood or by marriage (e.g. cousins, aunts, uncles, in-laws, nieces, nephews) if that person resides in the same household as the public official or public employee. So, keep yourself safe and stay far away from any public contract activity that impacts a member of your family.

Although the Ethics Commission just added domestic partners to the definition of family members, it has long been prohibited to hire or influence the public hiring of our other relatives.

This is an especially timely issue right now as seasonal hiring is upon us! Summer programs and seasonal jobs provide amazing opportunities for our family members to work in the public sector. However, public officials and employees are wise to review restrictions in the Ethics Law against hiring their family

members.

Public officials and employees are prohibited from directly hiring a family member into a public job as well as recommending or otherwise using public connections to obtain a job for a family member. The official or employee is required by law to completely remove themselves from participating in any way in the hiring process if one of their family members is competing for a public job.

Just a few examples of restricted activities include:

- A state employee contacts the agency HR department to recommend a sibling for a summer job at a state park
- A city council member asks the city to hire her child as a city pool lifeguard
- A school board member votes on stipends awarded to his/her spouse and other district employees for summer camps and summer school
- A township employee writes a letter of recommendation for a parent who is seeking seasonal landscaping work for the township

All public employees and officials are required to recuse in these and similar situations. Public officials voting on lists of names for seasonal hiring are responsible for knowing whether a relative's name is included in that list and abstaining accordingly. Authorizing or influencing even seasonal hires for family members is a potential violation of the public contract laws and potentially a fourth-degree felony.

It's also important to note that hiring restrictions involving minor children are even more restrictive. While it is understandable that many high school and college students seek summer jobs, the Ohio Ethics Law generally prohibits public officials and employees' minor children from obtaining a job with the same agency, municipality or office.

The only way in which a public employee or official's minor child can work for the same agency is if the public servant can demonstrate four things:

- The hiring process was fair and open;
- Broad opportunity to apply was provided for qualified and interested applicants;
- All qualified and interested applicants who are not related to agency officials or employees have already been hired; AND
- Vacancies still exist.

If these stipulations cannot be met, a minor child cannot accept a job for the public entity his/her parent serves.

2. Health Tip: Strength for Health. Resistance training is a key component of a healthier lifestyle. It increases bone density, strengthens muscle, and may help reduce risk of osteoporosis.

Physical activity recommendations:

- At least 150 minutes per week
- Add moderate to high-intensity resistance training

- Spend less time sitting
- Additional benefits by being active at least 5 hours per week
- Increase over time

Program design.

When developing a program, be sure to consult an appropriate medical professional to determine the correct starting point based on your health status. Consider the following when designing for specific strength goals:

- Repetition: One repetition, or "rep", is one complete movement of a particular exercise. It refers to the number of times you continuously repeat each exercise in a set.
- Sets: One set is a group of consecutive repetitions of a particular exercise without resting.
- Intensity: Defined as a level of muscular activity that is quantified in terms of work performed per unit of time.
- Variety: Referred to as switching around your routine, such as introducing new exercises over time.
- Rest interval: The time taken to recuperate between sets of exercise. The rest period will vary depending on the intensity of the exercise being performed.

Strength Training Tips.

- Warm up and cool down
- Add hand/ankle weights, or try circuit training
- 10 to 12 repetitions = 1 set
- Complete 1 to 2 sets of each exercise
- Exhale on exertion, inhale on recovery
- Avoid working a sore or injured muscle
- Rest for 1 to 2 days between workouts

FITT Principle:

- F Frequency: number of times per week you are planning to exercise.
- I Intensity: how difficult the exercise is or will be
- T Time, or duration, refers to how many minutes or repetitions of the exercise period.
- T Type refers to what kind of exercises (aerobic, muscle strengthening, balance, flexibility) are performed during

FACILITY MAINTENANCE DIVISION

- The City of Vandalia Annual Arbor Day Celebration event will be held this Friday, April 25 at Morton Middle School beginning at 10:00 a.m. A Crimson Sunset Maple tree will be planted on the school grounds with the 6th grade class attending the event and assisting with the tree planting. Each student will receive a White Flowering Dogwood seedling to take home for planting.
- Installation of the new playground unit at Robinette Park continues with an estimated completion of late next week (pictures at end of update). Once completed with equipment installation, the turf company will mobilize to begin installing the playground turf safety surface. We are planning for a ribbon cutting ceremony with a date to be determined since we have a better idea of completion of the project.
- Walkway leveling was completed at the VRC, Sports Complex, Senior Center, Justice Center, and Municipal Building. Uneven areas were removed to provide a safer walkway.
- Staff poured five concrete trash can bases that will be installed at the Art Park. Staff also installed a catch basin and drainage tile at the park to eliminate a water ponding issue along the east pathway area.
- o Issues with the underground electrical wiring at the sports complex occurred after the heavy rain event. Electrical Inspector Robert Martin will be testing some of the equipment in the park electrical room with the aid of a contractor. The issue(s) have not been rectified, but the ground has dried out enough that the problems are not occurring.
- Twenty of the twenty-two garden plots have been reserved by residents for the upcoming garden season. The gardens are in Jeffers Park.
- Commemorative tree planting at the sports complex, Seger Park, Art Park and Robinette Park
 has been completed by staff. A total of 11 trees were planted and included Wright Brothers
 Sugar Maple, Rogers Lustre Serviceberry, Shumard Oak, Early Glow Ohio Buckeye and Green
 Mountain Sugar Maple.

RECREATION CENTER

- Underwater Egg Hunt: On Saturday, April 12 we hosted our Underwater Easter Egg Hunt for children ages 3-12 years old. Eggs were hidden at the bottom of the VRC pool and participants were able to turn in their eggs for candy and prizes. Four lucky golden egg winners also received special Easter baskets! We had 59 registered participants for this program.
- Homeschool Takeover: On Friday, April 18, we hosted a Homeschool Takeover at the VRC. Homeschool groups and families were invited to come out and enjoy everything the VRC has to offer; swimming, climbing wall, gym activities, and Luther's Jungle. We had 40 families/groups attend, with a total of 190 participants.
- OPRA Mentorship Program: Aaron Messenger has been selected to be a mentor through the OPRA mentorship program for a recreation coordinator that is working for the City of Worthington. Their first meeting will be in the upcoming weeks.
- Dayton Foundation Grant Mobile Sensory Tent: The Vandalia Parks and Recreation Department was awarded a grant from the Dayton Foundation for \$3,650 to purchase supplies for the Mobile Sensory Tent. This tent area will be for those with sensory sensitivities and will be available at special events and recreation initiatives.
- Athletic Field Rental on WebTrac: Alicia, Aaron and Maecie met to discuss having athletic field rentals on WebTrac. We think this would be feasible, and Maecie will start working on putting information together so it can be uploaded to RecTrac/WebTrac.

SENIOR CITIZENS CENTER

- As of April 10, the Senior Center has been open for 70 days this year. In that time, 83 new members have joined. This does not count the numerous people who have called, stopped by, or taken the "nickel" tour but didn't join...yet.
- Toni and Alicia participated in a zoom meeting concerning the new grant process for our Vantran program.

RECREATION / ATHLETICS DIVISION / SPECIAL EVENTS

- We have a total of 435 kids playing in our Youth Baseball/Softball this season. This is up 30 kids from last season. Opening Day is Saturday, April 26th. There ceremony will start at 9:00 am.
- Registration for both Monday and Friday summer teams closed on Sunday, April 13th.

Subject: Information Update Ending April 25, 2025



- During the past five weeks, VPD officers made 14 traffic stops on commercial motor vehicles for traffic violations. These stops resulted in two traffic citations and seven written warnings, and one verbal warning while working 12 additional enforcement hours. Four verbal warnings were issued during regular patrol.
- VPD participated in Youth in Government Day on April 15 with VBHS junior Kailee Swisher accompanying Captain Sucher throughout the morning to get insight into how the police department functions and the services provided to the community. She participated having an interest in law enforcement and also comes from a law enforcement family.
- 3. On April 16, Captain Sucher met with city representatives at Cassel Hills Golf Course for our continued facility threat assessments.
- 4. On April 17, Officer Sommer and Captain Sucher attended the mock crash at Vandalia Butler High School. The event demonstrated the dangers of driving while impaired before prom. Special thanks to Vandalia Fire, Butler Township Police and Fire, and Premier Health for their participation.
- 5. On April 17, Captain Sucher presented to the Rotary Club, which focused on VPD's 2025 reorganization and update.
- 6. Detectives charged a 40-year-old Springfield man with Petty theft x3. The suspect stole cigarettes, food, and drinks from several Vandalia businesses. The male suspect was arrested by the Shelby County Sheriff's Office on an unrelated charge and incarcerated at the Shelby County Jail.
- 7. The posting for the open sergeant position closed on April 14. Six patrol officers applied for the position and have study materials for the upcoming exam. The process will include the examination, an administrative review completed by current sergeants on all the candidates, an assessment center, and interviews. The open sergeant position will be created after the next captain is selected.

- 8. Captain Walker continues to attend critical operations planning meetings for the upcoming NATO Parliamentary Assembly scheduled in Dayton, May 21-26, 2025. Dayton has requested mutual aid from all agencies around Ohio, and VPD will provide manpower assistance with security posts.
- VPD completed driver training over the past three weeks. Training was held north of the airport at the former Emery site and was in conjunction with multiple area agencies.
- 10. Captains Walker and Sucher, and Sergeant Lawson met with a representative from VINE/Versaterm on April 21. VINE and Versaterm have collaborated to build an automated victim notification system that would provide automatic updates to victims of crime throughout the entire criminal justice process. This system would provide notifications from the time the call is entered into our computer-aided dispatch system through prosecution and incarceration/release. The system is not available yet and is in the process of approval for funding at the state level.
- 11. Captains Walker and Sucher met with VFD personnel on April 22 to discuss and compare our procedures for missing persons.
- 12. Crime Prevention Officer Rich Sommer participated in a disaster drill at the Dayton International Airport. The drill involved a simulated plane crash and provided public safety agencies with the opportunity to work through our response and look for areas to improve.
- 13. We were honored to recognize our administrative professionals on Wednesday, April 23. Nancy Mandelik and Deborah Wright accompanied us to the annual lunch hosted by the Montgomery County Chiefs of Police Association at Sinclair Community College.
- 14. VPD has been in the process of expanding our employee wellness program. The program has evolved, with the input of a committee comprised of all levels within the Division, into a comprehensive program that includes physical, mental, financial, and spiritual health components. In 2025, we implemented an incentive-based physical fitness program. We held our first physical fitness test on April 24, where employees could earn incentives based on their performance. All sworn personnel were required to participate in the test, while civilian employees were optional. Special thanks to Butler High School for allowing us to use Memorial Stadium and the SAC for the test.
- 15. On April 24, Captains Walker and Sucher joined you in attending a security and parking meeting at Wright Bros. Aero for the 2025 Dayton Airshow. The Airshow will take place this year on June 21-22.
- 16. We hosted a retirement open house for Chief Althouse in the Community Room at the Justice Center on April 25.

- 17. On Saturday, we will host an assessment center conducted by the Ohio Association of Chiefs of Police for the police captain posting. Three OACP representatives who are police executives will conduct the assessment. We have three sergeants who are in the process for this position.
- 18. Vandalia PD will participate in this year's Light Ohio Blue campaign from May 2-15. May is Officer Memorial Month, when we remember those officers who have paid the ultimate sacrifice and given their lives in the line of duty. VPD Honor Guard members will participate in the annual countywide Officer Memorial Ceremony on May 2 at 11:00 a. m. downtown at Riverscape and the state's Officer Memorial Ceremony at the Ohio Peace Officer Training Academy in London, Ohio, on May 8.
- 19. On April 24, detectives, with assistance from Ohio Liquor Control agents, completed alcohol compliance checks on businesses in the City that have a license to sell alcoholic beverages. The results of this operation will be available in the next information update.

Development & Engineering Services (DES)

<u>Dog Leg Water and Sanitary Extension Phase 2 project:</u> Commissioning, including startup and final testing of the lift station, is anticipated for mid-May, following the installation of the alternate switch in the meter pedestal.

Vandalia Bikeway Connector project: Brumbaugh Construction has been working on Mechanically Stabilized Earth (MSE) wall #1 located on the west side of the railroad tracks near Taylorsville Dam, as well as constructing both bridge abutments for the new bikeway bridge. Meanwhile, Security Fence, the traffic signal subcontractor, has been boring new traffic signal conduits at the intersections of S Brown School Rd/Cassel Creek Dr/Scholz Dr and National Rd/Brown School Rd.

<u>2025 Curb/Sidewalk project:</u> Coate Construction has completed concrete work on Stoney Springs Rd and Cornish Dr. Coate has moved operations to Bright Ave.

Kenneth Avenue Watermain Replacement & Resurfacing project: Sturm Construction has installed the necessary insertion valves for the project and begun installing new water main along Kenneth Ave, starting from Larry Ave. Unfortunately, an unmarked gas service line was struck on 4/21, but CenterPoint Energy promptly made the repair.

<u>Tionda, Mossview, Ranchview Watermain Replacement & Resurfacing project:</u> M&T Excavating has delivered materials in preparation to start the project later this week or early next week.

Staff met with a possible developer looking at building a small 14 residential lot plat off of S Dixie Dr.

On April 14th, Chief Building Official (CBO) Mastrino and I conducted inspections of any structures within the floodplain that were affected by the early April flooding.

On April 15th, Vandalia-Butler High School juniors joined us for the senior staff meeting as part of Youth in Government Day. I had the honor of showing Cross Jordan aspects of my daily responsibilities, current City construction projects, and our Public Works crews in action.

Also on April 15th, Assistant City Manager Cron and I attended the Joint County (Montgomery & Miami) Commissioner Board hearing meeting on the Dayton International Airport Northeast Logistics Access (Ring Road) project, which allowed the public to voice their concerns about the proposed right-of-way (ROW) acquisition for permanent and temporary easements to construct the project.

On April 16th, CBO Mastrino and I participated in the Threat and Hazard Identification and Risk Assessment (THIRA) with other City staff for the Golf Course, Golf Maintenance, and Pool.

On April 17th, I attended the Miami Valley Regional Planning Commission (MVRPC) Technical Advisory Committee (TAC) meeting.

To celebrate Administrative Professionals' Day on April 23rd, DES and CMO staff came together for a cookout to show our appreciation for the incredible work our admin team does every day. A heartfelt thank you to **Christine Budich**, **Beverly Snider**, **Angela Swartz**, and **Sherri Howard** – your dedication, positivity, and support make a huge difference, and we're so grateful to have you on our team!

On April 24th, Public Works (PW) Superintendent Hayslett and I attended the 50% design review meeting for the NAWA Water Treatment Plant (WTP) Concentrate Disposal Improvements for the plant's new outfall to the Great Miami River. I also attended the biyearly Transportation Improvement Project (TIP) meeting with MVRPC and Ohio Department of Transportation (ODOT) regarding our grant-awarded projects in the early or design phase; these projects are Johnson Station Rd Bridge Replacement and Poe Ave/Wyse Rd/Miller Ln Resurfacing.

On April 25th, PW Superintendent Hayslett, CBO Mastrino, and I plan to participate in the THIRA with other City staff for the water towers and sanitary lift stations. We also plan to hold our monthly DES staff meeting afterwards.

I would also like to congratulate you on your approaching retirement from the position of Police Chief and officially into your new role as City Manager on May 1st!

Public Works (PW)

New Public Works Facility (810 Northwoods Blvd): Elevated Ground Solutions is cleaning up site and spreading mulch before demobilizing.

Streets:

Crews continued right-of-way (ROW) trimming brush along streets and sidewalks.

Crews replaced the seasonal banners along National Road, switching from the Springthemed designs to the Butler Aviators banners.

Crews began installing hardware on light poles along Dixie Dr in preparation for the new 2025-2026 Veteran banners.

Crews removed the salt v-boxes and snowplows off the single-axle dump trucks.

Water:

Crews continued hydro-excavating and repairing curb boxes that are broken or shifted over time hindering our access to the water service line curb stop valves.

Crews continued installing new water meters inside residences/businesses and outside in meter pits, where some have needed new angle valves which are located on the City side of the meter.

Crews continued turning (closing/opening) water main valves to confirm operational status throughout the City. This is an EPA requirement to perform turning on 20% of all valves each year.

Sanitary Sewer:

Crews responded to a reported sewer stoppage at 860 Sussex Pl. Upon arrival, the crew utilized the vacuum truck to break through the sanitary blockage. A root saw was then employed to thoroughly clean and clear the sewer line. The line is now flowing properly.

Crews placed asphalt at 775 Spartan Ave removed for a previous sanitary sewer issue.

Crews continued inspecting sanitary sewer main using the SL-RAT tool via sound waves.

Storm Sewer:

Crews continued catch basin (CB) restoration work identified during this year's inspections. These repairs are part of the preparation efforts for streets scheduled to be resurfaced this year.

At the CB on East Alkaline Springs Rd near the Art Park, crews formed and poured concrete for a new sidewall, front wall, and curb.

Crews' hydro-excavated to investigate and address sinkholes forming around CBs at 540 Dunnigan Dr and 1053 Robinette Ave.

Other Services:

On April 12th, crews staffed the monthly large item debris drop-off event at the PW garage. This free service is available to residents on the second Saturday of each month from March through October, between 8am and 2pm.

On April 17th, crews assisted with the mock car crash event at the high school. The front-end loader was used to position vehicles in the parking lot for the demonstration, and the street sweeper was utilized to clean the area afterward.

Crews began layout and excavation work for the Spring placement of concrete foundations at Poplar Hill cemetery.

Crews performed 116 utility locates this period for Ohio 811.

Vehicle Maintenance:

The mechanics serviced the street sweeper replacing the wetting system water pumps for dust control and installed a new starter on the vacuum truck for the auxiliary motor.

The mechanics repaired the wiring on one of the Arrow Boards and tilt trailers.

The mechanics serviced PW pickup truck #13 and replaced tires.

A special thank you to the Fire Division for allowing Fire Marshal Jacobs to train our crews in CPR and First-Aid on April 18th! Scott did an excellent job, and we greatly appreciate his expertise and time.

A conditional offer has been accepted for the open PW Technician position. The candidate is currently undergoing the physical examination and background check. We anticipate setting a start date in the near future.



Subject: March 2025 Crime Statistical Report Summary

Total calls for service to the Communications Center increased 10% to 1,096 calls in March 2025 compared to 997 calls in March 2024. There were 950 citizen-initiated calls for service (up 8.3%), and there were 146 officer-initiated calls (up 21.7%) in March 2025.

VPD investigated no homicides or robberies and investigated one rape in March 2025. There were nine assaults, and six domestic violence offenses reported in March 2025, compared to three assaults and five domestic violence offenses in March 2024. Assault cases increased by six (300%) in March 2025, compared to last March. Domestic violence cases increased by one (20%) in March 2025, compared to last March. Year-to-date, assault offenses are up 45.5% and domestic violence offenses are down 37.5%.

There were four burglaries reported in March 2025 compared to two burglaries reported in March 2024. There were seven felony thefts and eight misdemeanor thefts reported in March 2025, compared to ten felony thefts and eight misdemeanor thefts reported in March 2024. In 2025 year-to-date (YTD), burglaries/breaking & entering incidents decreased by 33.3% for a total of four offenses, felony thefts decreased by 27.3% for a total of 16 offenses, auto thefts are down 28.6% for a total of five offenses, and misdemeanor thefts decreased 32% for a total of 17 offenses when compared to 2024.

There was one criminal damaging/vandalism complaints in March 2025, down from eight incidents last March. Criminal damaging and vandalism offenses are down 61.5% YTD (eight incidents) compared to last year for a total of only five incidents this year. VPD officers focused on being visible in residential and business areas of the city to display a strong police presence and prevent crime. Officers made three felony drug arrests and three misdemeanor drug arrests in March 2025, compared to one felony drug arrest and no misdemeanor drug arrests in March 2024.

VPD made one more arrest in March 2025 compared to March 2024 with ten felony arrests and 18 misdemeanor arrests compared to seven felony arrests and 24 misdemeanor arrests last March. VPD officers charged five juveniles with an

offense in March 2025, compared to one juvenile in March 2024. There is a 26% decrease in juvenile arrests in 2025. These charges have primarily included sex offenses, domestic violence, drug and/or alcohol violations, and thefts.

During March, VPD officers made 291 traffic stops while patrolling Vandalia's roadways, a 14.4% decrease. These stops resulted in 50 citations, 199 written warnings, 37 verbal warnings, and five stops with other dispositions. Speed citations and other citations are down 14.5% in 2025 compared to 2024 YTD. OVI arrests were lower with four arrests in March 2025, compared to seven arrests in March 2024. Parking citations were lower in March 2025 with four violations compared with six parking violations in March 2024. These parking citations have primarily been violations of commercial vehicles parked in restricted areas on highway exit ramps.

VPD officers investigated 22 traffic crashes in March 2025, compared to 22 traffic crashes investigated in March 2024. Overall, traffic crashes are up 5.3% (3) in 2025 compared to 2024. Officers will continue to patrol Vandalia's roadways and work traffic enforcement to keep our roadways safe and reduce traffic crashes.

Officers responded to more alarm drops than a year ago with an increase from 43 business and residential alarms in March 2024 to 55 alarms in March 2025. Overall, alarm drops for 2025 increased by nearly 18% compared to 2024.

Overall, 2025 has seen a decrease in robbery, burglary, felony & misdemeanor thefts, auto theft, and domestic violence. There has been an increase in assaults and felony & misdemeanor drug arrests. There has been a decrease in total arrests and a moderate increase in traffic crashes and alarm drops. VPD officers will remain focused on patrol activities, crime prevention, and traffic enforcement while addressing community concerns related to these areas to keep our city a great place to live, work, and play.

FRIDAY, MAY 2, 2025 11:00A.M.


Law enforcement officers, elected officials, public dignitaries, family survivors, and the public are invited to join together on Friday, May 2, 2025, to honor the 49 Montgomery County law enforcement officers who have died in the line of duty over the past 145 years. The memorial ceremony will begin at 11:00 A.M. preceded by a procession of officers, retirees, and cruisers arriving at the ceremony site at Riverscape at 10:45 A.M.

The keynote speaker will be Ohio State Highway Patrol Lieutenant Colonel Charles J. Linek III. Lieutenant Colonel Linek began his Patrol career in February 1994. Lieutenant Colonel Linek oversees the Office of Planning, Research and Development, Office of Finance and Logistics, and the Office of Personnel with the Ohio State Highway Patrol. Lieutenant Colonel Linek also served in the Ohio Air National Guard from 1986 to 1992.

The family survivor speaker is Debbie Durr, the widow of Patrolman Jahn E. Schmidt of the Butler Township Police Department who was killed in the line of duty in 1976 on Miller Lane. A special music selection will be performed by American Idol finalist Alexis Gomez.

Free parking is available at 811 East Monument Street (east of Meigs Street and Tech Town) for all law enforcement personnel, command staff personnel, elected officials, and government leaders. Shuttle service will be available to and from the parking lot to the procession staging area and the ceremony location. Additional parking is available at parking meters downtown. Family survivors will be provided special parking passes. To ensure safety of the vehicles, volunteers will be monitoring the designated parking lot during the ceremony.



For officers and retirees walking in the procession, you will need to assemble in the parking lot of Temple Israel, 130 Riverside Drive, by 1000 hours. The procession will begin promptly at 1030 hours.

Due to the limited space at Riverscape and Temple Israel, each police agency is to have <u>ONLY ONE</u> marked cruiser in the procession and to stage in the Temple Israel parking lot. <u>THERE IS NO EXTRA PARKING AVAILABLE FOR CRUISERS OR PERSONAL VEHICLES AT TEMPLE ISRAEL.</u>

A complimentary luncheon for law enforcement officers, retirees, scholarship recipients, guest speakers and family survivors will follow the ceremony at the Antioch Shrine, 120 East First Street, compliments of Kettering Health. Shuttle service will be provided to and from the Antioch Shrine to the parking area.
