Mayor Herbst & City Councilmembers:

This past Thursday, we enjoyed our July Employee Appreciation Event with Pizza in the Park at Helke Park. It was great to see and interact with many of our employees, who provide valuable service and contribute to maintaining the amenities in our community. This token of



appreciation is another way to acknowledge and thank them for their contributions.

On July 12, staff from the Police & Fire Divisions and Public Works participated in a Touch-A-Truck event at Scene 75 where they had the opportunity to showcase their department's vehicles and equipment and meet many families who attended this special event. This is always an exciting time for kids to experience the thrill of sitting in a dump truck, fire engine, or police vehicle and have positive interactions with our employees.

The Vandalia Bikeway Connector Project continues to progress well with the bridge set in place

over CSX railroad and the rebar and concrete deck & curbs as well as the final abutment and approaches put in place. The new traffic mast arms at South Brown School Road and East National Road are in place and the older poles and mast arms will be moved and re-erected at the South Brown School Road/Cassel Creek Drive/Scholz drive intersection soon. Brumbaugh Construction plans to complete the remainder of this project by mid-September in time for great Fall hiking and bike rides.





Our 2025 street resurfacing project is complete with Barrett Paving wrapping some final work by installing termoplastic striping, applying asphalitc concrete sealant, and raising manhole lids and water main valve boxes so they are level with the new pavement. We thank the community for their patience and understanding as we work to continue to improve our roadways.

As part of our 20-year water tower maintenance contract, USG Water completed the new exterior paint coating on the Inverness Ave. water tower, making this the first water tower in the City with the new logo. The Attica St. and Sports Complex water towers are scheduled for new exterior paint coatings in 2027 and 2028, respectively.

The irrigation replacement project at Cassel Hills Golf Course began this week with initial ground-breaking. Currently, no holes are affected, but staff will be keeping golfers informed as the work progresses and letting them know which parts of the course are being impacted as this project continues.

Summer CampREC continues to be an exciting time for many youth who attend and enjoy the fun activities staff have organized and planned. The Rec Center is an active site of many great events and programs throughout the summer months as you will read in the Parks & Recreation Update. As a reminder, the VRC pool will be shutdown from July 28 to August 8 for annual maintenance, but Cassel Hills Pool is a great option to visit during these hot summer days.

We welcome our two newest full-time members to the Division of Fire. Bryan Sowers was selected as the new Community Risk Reduction Coordinator and Eli King transitioned to a full-time firefighter/EMT. It was a pleasure to introduce both to Council and swear them in at this week's Council Meeting.

After a competitive recruitment process, I am excited to announce that Alicia McCracken will be our new Parks & Recreation Director, replacing Steve Clark who retired earlier this month. Alicia is a life-long Vandalia resident, an Aviator and VBHS graduate, and an 18-year staff member with Parks & Recreation. Alicia has experience as a recreation supervisor, facility manager, and recreation superintendent and is a Certified Parks and Recreation Professional (CPRP). She brings passion and vision to her new role as P&R Director and will be a great asset to the city in her new role. Congratulations Alicia on an outstanding job!

We will be hosting the Robinette Park Playground Ribbon Cutting on Friday, August 15th at noon. Plan to join us as we celebrate the grand opening with the installation of the new playground equipment. Thanks to staff for the time and effort they spent planning and working to enhance the park with new equipment and restrooms as well as our elected officials who provided state funding to support this project.

As a reminder, there will <u>not</u> be a Council meeting on Monday, August 4th due to the Council's Summer schedule. The next scheduled City Council meeting is Monday, August 18th at 7:00 pm.

Re: Information Update for July 12 - 25, 2025

- Rich Hopkins and I attended the Minter Bank five-year anniversary Ribbon Cutting event last week. While Minster Bank is not technically in the city, they are a great partner in our community and help sponsor many city events, including the Star Spangled Celebration and our Business Appreciation Day Golf Outing.
- We had a great Employee Appreciation pizza party at Helke Park on Thursday, July 24th. Thank you to everyone involved in the planning and set up for the event.
- We met with the listing agent at 6928 Poe Avenue to tour the building and site that was previously Tire Discounter. We will be looking to assist them in finding a tenant for that facility along with the property to the east as they own both buildings.
- You and I attended the I-70/&75 Development Association's monthly meeting last Friday. This month's speakers were a panel of local City Managers discussing various topics that affect all cities, including property tax reform and highlighting development projects in their own cities.
- Ben Graham and I spoke with the consultant for Addison Properties on the next steps and our process for their final plan, along with the platting and bonding for their development. We should be receiving their first draft of the Traffic Impact Study within the next couple weeks.
- I had a Business Retention meeting this week with owner, Joe Minneman and vice president, Dan Norris at All Service Plastic Molding at 900 Falls Creek Drive. Their business is doing very well and they employ approximately 300 people at this location. They were very complimentary of current and former staff members at the city and have hopes of expanding their operation here.
- Staff have had several meetings with representatives for the DR Horton proposed development on Corporate Center Drive leading up to the July 8th Planning Commission meeting and the July 21st City Council Study Session. Many options and scenarios were discussed and considered before they submitted their proposal.
- You, Ben Borton, Bridgete Leiter and I attended the NAWA monthly board meeting on July 24.
- You and I met with Butler Township Administrator, Erika Vogel, to discuss the western section of Mulberry Road that is in the township and if there has been any progress on the sidewalk connection along Stonequarry Road.

- We had our first training session this week with new budget software, ClearGov.
- We continue discussions with two separate companies that have interest in the large facility at 1669 Capstone Way.
- Ben Borton and I participated in our monthly joint meeting with Montgomery County Engineer's Office, Montgomery County TID, Miami County Engineer, Butler Township, City of Union and Monroe Township to discuss many of the ongoing and proposed roadway and development projects surrounding the airport. We plan to meet monthly just to keep everyone updated and on the same page as we all try to encourage development but also try to minimize the impact on roadways and our residents.
- The Foxfire Section 9 development is continuing to build out the new residences. There have been 17 new house permits issued of the 29 lots available, with several already completed.
- A permit was issued for the renovation of the car wash at 20 Helke Road.
- There is one item scheduled for the August 12 Planning Commission meeting. The applicant is seeking a PUD Plan and Preliminary Plan approval for a residential development on Mulberry Road south of the Copperfield Development.
- Staff met with representatives of the City of Beavercreek to discuss our Hotel/Motel Ordinance and enforcement process. They are looking into a similar ordinance.
- Rich Hopkins taped the August edition of Focus Vandalia this week. Next month's topics will include the new Parks & Recreation Guide, Vandalia's contribution to the Great Miami River Cleanup scheduled for August 2nd, our new Purple Heart Signs that have been installed at our city's borders, the opening of the Robinette Park Playground, and an introduction to Bryan Sowers, our new Community Risk Reduction Coordinator.

 I attended a council study session and meeting. I presented the June YTD financial report; assessment Ordinance for delinquent utility account balances due; Resolution for a contract extension agreement between the Auditor of State's Office, City of Vandalia and Plattenburg & Associates, Inc.

- 2. Finance staff appreciated the invitation to the Employee Appreciation Luncheon.
- 3. I attended a Tri-Cities Finance Committee meeting where I presented the June YTD financial report.

Year to date (2025) Revenues for sewer service are up 9.99% from June 2024. Interest revenue is down YTD.

Year to date (2025) Expenses (which includes Operating & Maintenance, Capital and Debt service payments) are up 172.14% from June 2024 due to timing and the explanations below.

Explanations for differences in expense amounts from 2025 vs 2024:

General Fund:

- 1. Legal Services increase due to issues regarding land use and appropriation of property related to the plant improvement project.
- 2. Repairs and Maintenance decrease due to tree trimming costs incurred in 2024.

YTD actual expenses were 49.95% of the budgeted amount partly due to timing, and the explanations referenced above.

Expenses (Capital Improvement Fund)

YTD actual expenses were 52.78% of the budgeted amount partly due to timing, and the explanations references above.

- 7. I participated in the wiring of funds and closing regarding the sale of the Land Acquisition Notes on July 17th.

SENIOR CITIZENS CENTER

- 1. Eleven new members joined the Senior Center in July.
- 2. Staff is working on getting quotes for a new fire alarm system.
- 3. The Golden Qi (seated Tai Chi) class has been popular this month. They are averaging 15-20 participants.
- 4. New blinds were installed in the Card Room.



FACILITY MAINTENANCE DIVISION

- 1. Watering of trees Parks staff watered the street trees along National and Dixie, the street trees surrounding Victory Park and the trees planted this Fall. Approximately 100 trees are using the watering bags. Staff also watered some of our newly panted landscape beds.
- 2. Parks staff applied weed control in landscape beds and turf inside the Cassel Hills Pool areas. The consistent and abundant rainfall has depleted our spring pre-emergent application. We are in the process of applying the product again since this is the first time we have had this. In the past the spring application has sufficed because of the drier summer weather and the slowdown of weed emergence.
- 3. Buildings staff have been working on the preparation of the storage room at the Municipal Building.
- 4. Parks staff is placing gravel in an area behind the Municipal Building. The purpose is to improve the appearance of this area, make the area easier to maintain, and eliminate mud splashing up on the rear door and around the HVAC components in this area.

- 5. On July 16, VPD supervisors held our monthly staff meeting.
- 6. Captain Walker attended a BWC safety breakfast on July 17, hosted by the Dayton Area Chamber of Commerce. The topic covered was building a driving safety program.
- 7. On July 17, VPD administrative staff and Finance Director Leiter met to discuss our 2026 budget and use of ClearGov budgeting software.
- 8. On July 17, an FBI representative from the Cincinnati office met with VPD staff regarding a partnership for internet-based crimes.
- 9. Captain Walker attended a web meeting on July 21 with representatives from the Butler Township Police Department, Vandalia-Butler City Schools, and ADAMHS. Current practices with the Handle With Care program were discussed. This program involves law enforcement notifying the local schools of a student they came into contact with who may have been through a traumatic event.
- 10. On July 21, Chief Sucher attended the Council Study Session to make a recommendation on a pending liquor permit for Flying J.
- 11. On July 22, Chief Sucher had a virtual meeting with representatives from Getac to test and evaluate their body worn camera and in-car video system.

- 12. On July 23, Officer Sommer attended Summer Market at the Vandalia Recreation Center. The event had multiple vendors and food trucks.
- 13. On July 24, Chief Sucher and Captain Walker attended a roadshow by Axon to observe their body worn camera and in-car video systems.

Development & Engineering Services (DES)

<u>Dog Leg Water and Sanitary Extension Phase 2 project:</u> Capital Electric is in the process of installing security lighting at the Dog Leg Rd and National Rd lift stations. DES staff and Outdoor Enterprises are working together on punch lists.

Vandalia Bikeway Connector project: Brumbaugh Construction has laid the rebar and poured the concrete deck & curbs and final abutment & approaches at the new bikeway bridge over the CSX rail lines. AES set the new electrical meter for the new traffic signals power at the National Rd/Brown School Rd intersection. Security Fence plans to switch traffic control to the new signals next week and remove the existing poles & mast arms; a PD officer will be on scene, assisting with traffic control during this operation. These poles/mast arms are to be reused and re-erected at the S Brown School Rd/Cassel Creek Dr/Scholz Dr intersection with this project. Brumbaugh plans to complete the remainder of project by mid-September.



Kenneth Avenue Watermain Replacement & Resurfacing project: Sturm Construction's subcontractor Robinson Concrete continued working on the concrete curb & sidewalk repairs. Sturm is planning to mill & pave Kenneth Ave mid-August.

<u>Tionda, Mossview, Ranchview (TMR) Watermain Replacement & Resurfacing project:</u> M&T Excavating continued connecting new water service laterals to residences' existing curb stop valves.

<u>2025 Sanitary Sewer Lining project:</u> No progress. The mains are lined but we're still waiting on Insight Pipe Contracting's chemical grouting subcontractor to perform the grouting of service laterals into the main.

<u>2025 Street Resurfacing:</u> Barrett Paving Materials has completed the paving work. Some final thermoplastic striping, placing of asphaltic concrete sealant (AC), and raising of manhole (MH) lids & water main valve box lids remain.

Damian, Soter, Romanus, Desales (N) Watermain Replacement & Resurfacing: Council awarded this contract to CG Construction & Utilities at the July 21st Council meeting. Contract paperwork is being signed and submitted. A pre-construction meeting is scheduled for July 29th. CG wants to start soon. Once all paperwork is fully executed and we have a firm start date from CG, we will send out notices to the affected residents in the project area (map attached). CG has relayed to DES staff the desire to install all of the new water main and restore their trenches with temporary asphalt before the asphalt plants close this Autumn/Winter.

The following sites have been inspected or reviewed by DES staff:

- Certificate of Occupancy (CO) issued: Curry & Grill restaurant at 722 W National Rd (old Stubbies)
- Certificate of Occupancy (CO) issued: Heraeus Epurio at 970 Industrial Park Dr for 1 hazardous storage building
- 17 of the 29 single-family homes in Foxfire Section 9 under review, construction & inspection, or completed (7 have issued COs)
- Ongoing inspections: Redwood Phase 2 apartments at the east end of Park Center Dr (broke ground on 4 of the 11 buildings)
- Ongoing inspections: Rodz Builders office at 234 W National Rd
- Application under review: tenant upfit of half the building at 1669 Capstone Way
- Application under review: condominium building at The Landing (650 Pool Ave, old Willow pool)

Eggeman Engineering & Consulting continued performing traffic counts for the Ohio Department of Transportation (ODOT) throughout town (zero cost to City). These could be seen as black hoses stretched across the roadways attached to counting devices.

As part of our 20-year water tower maintenance contract, USG Water completed the new exterior paint coating on the Inverness Ave water tower, making this the first water tower in the City with the new logo. Attica St and Sports Complex water towers are scheduled for new exterior paint coatings in 2027 and 2028, respectively.





I attended the Miami Valley Regional Planning Commission (MVRPC) Technical Advisory Committee (TAC) and Safe Streets for All (SS4A) meetings on July 17th. MVRPC is developing a comprehensive road safety action plan (the SS4A) and invites everyone to provide input to identify pedestrian, bicyclist, and motorist safety issues.

To learn more about this SS4A plan, please visit MVRPC's website (https://www.mvrpc.org/transportation/safe-streets-all-action-plan) or an upcoming project open house (flyer attached); the closest open house to the City will be at the Tipp City Government Building on August 5th 4-6 pm.

Assistant City Manager (ACM) Cron, DES staff, and Fire Marshal Jacobs met for our monthly development meeting on July 21st to discuss ongoing and proposed projects, ensuring all parties remain aligned and informed.

I attended a Source Water Protection Program Multi-Jurisdictional Partners meeting on July 23rd to establish a recurring coordination meeting twice a year to discuss

ACM Cron and I attended the monthly Miami/Montgomery County Coordination meeting on July 24th to discuss the ongoing infrastructure improvement projects around the airport.

DES & PW staff have held numerous internal meetings in preparation for the upcoming budget season, including discussing and prioritizing proposed projects.

Northern Area Water Authority (NAWA) – water supply treatment:

PW Superintendent Hayslett and I attended the monthly NAWA Outfall Channel project review meeting for the plant's new outfall to the Great Miami River and the monthly technical committee meeting.

ACM Cron, Finance Director Leiter, yourself, and I attended the NAWA board meeting, held every 2 months.

<u>Tri-Cities North Regional Wastewater Authority (TCA) – wastewater treatment:</u>

TCA crews have been videoing sections of the sanitary sewer to help DES staff define project boundaries and count numbers of sewer laterals in specific spans as we prepare budgets for upcoming projects.

Public Works (PW)

New Public Works Facility (810 Northwoods Blvd):

Chief Building Official (CBO) Mastrino, ACM Cron, PW Superintendent Hayslett, IT Manager Davey, Electrical/Building Inspector Martin, and I continue to meet with WDC Group, Choice One Engineering, and other subconsultants on a two-week basis to discuss the new facility and assist with the development of the final design.

PW Superintendent Hayslett, IT Manager, and I met specifically to sketch out power outlet, data & phone port, water hose bib, and compressed airport locations in the main building.

CBO Mastrino and Fire staff performed water main flow tests on N Brown School Rd and near Dollar Tree on Northwoods Blvd to aid in the water suppression design.

Crews mowed the large growth of weeds along the Dollar Tree and Robinette Park sides using our trackless machine.

Streets:

Crews have been doing a staged approach to grinding out deteriorated asphalt and concrete and placing back new asphalt with traffic control at the National Rd/I-75 overpass bridge abutments.

Crews continue street sweeping to remove debris from the curb gutters and prevent materials from being washed into the storm sewer during storm events.

Crews fixed a sinkhole on Little York Rd, just west of the CSX tunnel.

Crews continued spraying curb gutters as part of our annual herbicide program. Crews started on the east side of the City and are working west, currently just west of I-75 now.

Storm Sewer:

Crews continued to sweep the streets to remove debris from the curb gutters and prevent materials from being washed into the storm sewer during storm events.

Water:

Crews completed the repair of an Eddy fire hydrant (FH) on Dunnigan Dr; parts took about five weeks to come in.

Crews replaced an old FH on La Torrette Ct where it was found to have some operational issues.

Crews continued installing new water meters inside residences/businesses and outside in meter pits.

Sanitary Sewer:

Crews rebuilt the sanitary manhole (MH) near 113 Westhafer Rd; the blocks below the casting were caving in and was going to cause a hazard to vehicles driving over. Crews installed new concrete riser rings under the MH casting, placed concrete around the rings, and placed asphalt to the roadway surface.

Crews performed monthly sanitary sewer lift station maintenance: making sure pumps are working correctly, pump float balls are cleaned, and documenting pump hours.

Crews obtained monthly Municipal Industrial Pretreatment Program (MIPP) samples at Veolia Water and Pratt Industries.

Other Services:

Crews participated in Scene 75's Touch-a-Truck event at their facility on July 12th, displaying some equipment, allowing the public to get up close, and explaining some of the work PW does for the community.

Crews staffed the monthly large item debris drop-off event at the PW garage on July 12th. This free service is available to residents on the second Saturday of each month from March through October, between 8 am and 2 pm.


Crews performed two burials at Poplar Hill cemetery during this period.

Vehicle Maintenance:


The mechanics serviced pickup truck #14 and fixed our excavating bucket.

PROTECTING YOUR PROPERTY AGAINST DEED FRAUD



The Fraud Alert Notification System is a free notification service that notifies subscribers of all documents recorded against their property.

What is Deed Fraud?

Property deed fraud occurs when an individual files a fraudulent document with the county Recorder's Office, falsely claiming ownership of your home or property.

This document is usually forged and often involves a complicit notary.

Typically, the person committing the fraud does not intend to live in the property; instead, they aim to sell it quickly to an unsuspecting buyer at the property's value.

Property deed fraud can generally be reversed if detected early. For this reason, the Recorder's Office offers a notification system for all property owners in Montgomery County and encourages them to enroll.

Properties at high risk of being stolen are:

- Vacant properties abandoned due to delinquent taxes.
- Vacant properties waiting to be probated.
- Rental properties.
- Homes newly listed for sale.
- Properties vacated by snowbirds.
- Properties left unattended for any other reason.

What is the Fraud Alert Notification (FAN) System?

The Fraud Alert Notification System, also known as the FAN System, is a FREE service that notifies subscribers of all documents recorded against their property.

To start receiving notifications, property owners must enroll and indicate whether they prefer to be notified by mail, email, and/or text. Once enrolled, they will receive a welcome letter along with a decal to display on their property.

Every time a document is recorded, the property owner will receive a notification letter/message that includes the file number of the recorded document.

Property owners can look up the file number on our Records Online Search at mcrecorder.org, or they can call our office at 937-225-4275 to have the document searched for them.

If a recorded document is suspected to be fraudulent, the property owner should contact the Recorder's Office immediately. Upon receiving a complaint, the case will be referred to the Prosecutor's Office for criminal investigation.

Note: Enrolling in the FAN System does not prevent a possible fraudulent document from being recorded. It does, however, alert the property owner of a transaction so they can verify the contents of the document sooner than later.

Additional Tips to Protecting Your Property:

- If your property is left unoccupied, check often to ensure it is not occupied illegally. Ask someone you trust to look after your home if you are going to be away for an extended period of time.
- Do not let mail pile up if you are going to be out of town.
- Make sure the County Treasurer has your correct address for you to receive all property tax notifications. Contact them if you suddenly stop receiving these notices.
- Seek a real estate professional when buying or selling a property to ensure a clean transaction, especially when entering into a Quit Claim Deed.

TRANSFER ON DEATH (TOD) DESIGNATION AFFIDAVIT

TAKE ACTION IN PROTECTING
THE FUTURE
OF YOUR PROPERTY

What is a TOD?

A TOD is a Transfer on Death designation document that allows you, the property owner, to designate a beneficiary of your real estate property.

What does the TOD do?

The TOD names the beneficiary of your property. It has no effect on ownership until you die. The benefit of recording a TOD is to spare the beneficiary from going through Probate Court to have the property put in their name.

Can a TOD be revoked?

Yes. A TOD designation can be revoked or changed at any time before your death without the consent of the death beneficiary.

What types of properties are covered by a TOD?

TODs recorded in the Montgomery County Recorder's Office cover real estate property located within Montgomery County. This includes: residential, commercial, industrial, and agricultural.

How do I go about recording a TOD?

A TOD form can be acquired from the Montgomery County Recorder's Office. Forms are available in the office for pickup or can be printed from mcrecorder.org. Complete the TOD form and have it signed in front of a valid notary. Once the document is complete*, it can be recorded in our office for the standard recording fees.

What does the beneficiary need to do after my death to take ownership?

The beneficiary does not automatically take ownership upon your death. They must record an Affidavit of Confirmation (AOC) along with a copy of your death certificate.

AOC forms can be acquired from the Montgomery County Recorder's Office. Forms are available in the office for pickup or can be printed from mcrecorder.org. Once the form is complete* and signed in front of a valid notary, it can be recorded in our office for the standard recording fees.

What if I sell the property after recording a TOD?

If you sell your property while there is a TOD on record, the new Deed changing ownership will override the TOD without it needing to be revoked. The original beneficiary will now have no interest in your property when you die.

* The Recorder's Office is not permitted to give legal advice or assist in the completion of the forms provided.



FAQs About the FAN System

How do I enroll in the FAN System?

You can enroll online anytime at <u>mcrecorder.org</u> or in person at the Montgomery County Recorder's Office on the 5th floor of the County Administration Building between 8am and 5pm. Paper forms can also be downloaded from the website. If you do not have access to a computer and would like a paper form sent to you, call the office at 937-225-4275.

How does it work?

Once you have been successfully enrolled in the system, you will begin getting notified every time a document is recorded in the Montgomery County Recorder's Office.

How will I be notified?

During the enrollment process (online or on paper), you will elect whether you want to be notified by mail, email, or both.

Can I get notified by text?

No. Email or mail are the only options available at this time.

How much does it cost?

This is a FREE service offered to Montgomery County property owners.

What if I receive notification about a transaction?

Not all notifications mean fraud. You will be notified every time a document is recorded in our office whether you are aware of the transaction or not. (i.e., you may pay off your mortgage and the lender files a release/satisfaction of mortgage.) When you are notified of the transaction, you will be given an instrument number of the document recorded. You can look up the number on our Records Online Search at mcrecorder.org or you can call our office to have the document looked up for you.

What if I receive notification about a transaction that I believe is FRAUD?

Contact the Recorder's Office immediately to file a complaint. All complaints are heard by the Recorder personally before being referred to the Prosecutor's Office for investigation. An "Affidavit of Facts Relating to Title" form must be recorded disclosing the facts of the complaint.

What if I do not want to receive notifications anymore?

Maybe you have sold the property or no longer want to be notified. The only way to stop receiving notifications is to "OPT OUT" of the program. You can do so by visiting https://go.mcohio.org/applications/recorder/fraud/findRegistered.cfm. The security phrase that was created at the time of enrollment is needed to opt out or make any changes to your notifications. If you are having problems opting out of the program, call the office at 937-225-4278 for assistance.

This free program helps veterans securely record their DD-214 and obtain a valid state-issued ID card. This ID can help them access healthcare benefits, burial benefits, specialized veteran loans, store discounts, and much more.

BENEFITS OF A VETERAN ID CARD

- Your Veteran ID Card serves as proof of honorable military discharge.
- A card is more convenient to carry.
- Can be used to assist with obtaining eligibility for hospital, burial, service credit benefits, store discounts, and more.
- The Veteran ID Card is complimentary for eligible veterans.

DID YOU KNOW...

If you show your wallet-sized Veteran ID Card issued by the Montgomery County Recorder's Office, you will receive year-round discounts from businesses not only in Montgomery County, but also across the state of Ohio and the United States.

A list of businesses that offer veteran discounts will be provided upon receiving your Veteran ID Card.

VETERAN ID CARD REQUIREMENTS

Under the Ohio Revised Code, any veteran who presents and records a copy of their DD-214, identifying an "honorable" discharge, is eligible to receive a Veteran ID Card.

In addition to recording a DD-214, veterans MUST bring two of the following forms of identification:

- Birth certificate
- ID card from the U.S. Department of Veteran Affairs
- U.S. military ID
- Social security card
- CCW license
- Ohio drivers license
- State issued ID
- Valid U.S. passport

*This Veteran ID Card does not independently qualify a veteran for benefits offered by the U.S. Department of Veteran Affairs (VA). The VA retains sole discretion in determining eligibility for their benefits.

DD-214 INFORMATION

If you do not have your DD-214, you MUST call (937) 225-4801 to schedule an appointment with the Montgomery County Veteran Services office to request a copy. Their office is located on the 4th floor of the East Medical Plaza Building at: 627 Edwin C. Moses Blvd., Dayton, OH 45417.

- Once you have received your DD-214, you are able to record it in the Recorder's Office FREE of charge.
- Upon recording, the DD-214 must stay in the Recorder's Office overnight and will be mailed back the following business day. A certified copy of your DD-214 will be provided at the time of recording.
- At no time is the information from your DD-214 displayed on public record.

The Montgomery County Recorder's Office is now equipped to record DD-214's and issue Veteran ID cards offsite. Please visit www.mcrecorder.org for a list of upcoming events or email mcrecorder@mcohio.org to request our participation in your event.
