A RESOLUTION OF INTENTION TO APPROPRIATE INTEREST IN PROPERTY LOCATED ALONG SOUTH DIXIE DRIVE FOR PUBLIC ROAD PURPOSES.

WHEREAS, the orderly and balanced development of the City of Vandalia is necessary for the health, safety and general welfare of the citizens; and

WHEREAS, there is a need for acquisition of right-of-way for maintenance and improvements to the public roadway known as South Dixie Drive; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF VANDALIA, MONTGOMERY COUNTY, OHIO THAT:
