Honorable Mayor Herbst & Esteemed City Councilmembers:

Congratulations to Mrs. Melissa Pruszynski: I am proud to announce that I have appointed Mrs. Melissa Pruszynski as the new Human Resources Manager. I plan to formerly introduce her and to congratulate her at Tuesday's meeting of City Council. The City will issue a formal press release next week. HR Manager Pruszynski holds a Bachelor of Science degree in Criminal Justice Administration from Park College and is a member of the National Public Employer Labor Relations Association. She has served the City of Vandalia as a full-time employee for 30+ years and knows the organization well. During her tenure, she has devoted 10 years to the City Manager's Office, 10 years to the Department of Parks & Recreation, and 11 years to the Vandalia Municipal Court. During the search for the new Human Resources Manager, Mrs. Pruszynski assumed many of the HR duties in addition to those of her former position. As part of this recruitment, HR Manager Pruszynski met with each of our department heads to understand their needs and to begin the journey of elevating the effectiveness of her post. This inquiry yielded unanimous support from the City's senior staff. Mrs. Pruszynski has a reputation for hard work and commitment to the City of Vandalia. Her knowledge of our organization and eagerness to succeed are two contributing factors that make her the right fit for this position. This year, HR Manager Pruszynski will work to bring trust, credibility, and strong internal customer service skills to the HR Office. Some of her top priorities will include directing the City's online performance evaluation system, improving recruitment efforts – especially for part-time and seasonal posts, analyzing part-time wage structures, and updating personnel policies. With Officer Matlock on board, we are at full staffing – including 32 sworn Police Officers. Expenses for this additional position are being offset by a grant.

City – VBCSD – Butler Township Joint Meeting: The Vandalia Butler City School District, Butler Township, and the City of Vandalia thrive as a community when we are able to collaborate and work toward common goals. For this reason, we will hold a joint meeting between the jurisdictions on January 31, 2022 at 5:30 p.m. in the Butler Township Hall located at 3780 Little York Road. Please advise me of any items that you would like to add to the agenda. This meeting is open to the public.

Watermain Breaks: Thank you to our Public Works Crews for being on top of our three watermain breaks this week. Supervisors DeWayne Hopkins and Mike Busse are exhibiting excellent leadership as we work to recruit the next Public Works Superintendent.

Retirement of Ted Baker: Chief Building Official Ted Baker will be retiring from The City of Vandalia on January 21, 2022. Ted has dedicated over 33 years to the City of Vandalia in this role as Chief Building Official and has seen the City grow



tremendously. Ted has been involved in practically every structure built (and demolished) in the City since the summer of 1988. I have enjoyed working with and learning from Ted over the last year. I know that Ted will be deeply missed by the Development and Engineering Services family and by many others around the City. # Monday, February 7, 2022 Items

Resolution: Fireworks Display - A request for qualifications (RFQ) was issued on December 3, 2021 for the identification of a professional fireworks company to provide fireworks display services for the Annual City of Vandalia Star Spangled Celebration. The purpose of the RFQ is to identify and to select a highly experienced and qualified firm to provide a safe and turnkey firework display for the 2022 and 2023 Star Spangled Celebration events with an option for two, one-year extensions that could take the agreement through 2025. The RFQ was advertised in the Daily Court Reporter as well as the City of Vandalia website. Two (2) firms submitted formal proposals prior to the December 17, 2021, deadline



with a third company missing the submittal deadline. The qualifying proposals include Pyrotecnico Fireworks, Inc. of New Castle, PA and Rozzi's Famous Fireworks of Loveland, OH. American Fireworks of Hudson, OH did not meet submittal deadline. Based on a review by the Parks & Recreation Department and the Division of Fire, I am recommending the City enter into a two-year Professional Services Agreement with the potential for two, one-year terms that could take the agreement through 2025 with Rozzi's Famous Fireworks for the Annual Star Spangled Celebration Fireworks Display at an amount of \$28,000 for 2022 and \$29,000 for 2023. The amount for the option years of 2024 and 2025 will be determined if the City chooses the option to extend the agreement. As a side note: Butler Township has approved a two-year commitment to sponsor the fireworks. I have reached out to Butler Township to secure their partnership for this year's event, and I am waiting to hear back. In addition, staff is in the process of lining up the regular sponsors of this event. The City's net cost for the Celebration in 2018 was \$12,703. Thank you for considering this expense as we plan to celebrate and to honor our freedom in the United States of America!

Resolutions: Job Creation and Revitalization Fund and Program – The Vision Vandalia Comprehensive Plan calls for the development of a discernable downtown area for residents to gather, dine, shop, and enjoy life in Vandalia. As a team, we have discussed several objectives in the pursuit of driving development that will improve quality of life in Vandalia. As part of this strategy, I am proposing that Council designate a Job Creation and Revitalization Fund for the purpose of reinvesting back into the City through property acquisition, abatement of blight, improvements to utilities and the right of way, direct investment, and grants to foment desirable projects that have not heretofore occurred through the free hand of the market. On Tuesday, I will introduce two resolutions for your consideration. The first establishes a new fund. As part of our strategy, I propose that revenues from building permit fees (and other development fees) within the municipal corporate limits be allocated to this fund, in addition to revenues from the sale of property within the Job Creation and Revitalization Area. I have enclosed a map of the proposed Job Creation and Revitalization Area. As a team, we have discussed appropriating seed money and unanticipated revenues to this fund. I plan to bring this to Council for deliberation after the 2021 books are fully closed and the fund is created. Also included, is the companion resolution establishing the Job Creation and Revitalization Program. This program is similar to the program in Huber Heights and formally authorizes the City Manager to negotiate and to expedite other select economic development tasks on behalf of the City. In this case, I believe that the resolution serves as a guide for determining my role and the actions (and appropriate limitations) that I may take to accomplish strategic development in the outlined area.

Resolution: Building Department Software - The Development and Engineering Services Division is seeking an upgrade to its current building and tracking software. The current software was adopted in 2013 and is no longer supported. The new software, Municity / Laserfiche, will improve efficiency, customer service to residents and businesses, and integrate with our ESRI GIS Software to improve record management. The upgrade fits squarely within the *Sharpen the Saw* 2022 policy goal as the new software will allow staff to work directly in the field from a variety of electronic devices when conducting inspections and writing reports in the field. The system will eventually enable the City to receive digital submissions and to conduct electronic plan reviews, which will reduce turnaround times. The 2022 capital



budget included \$64,000 for the initial purchase of the software with the balance of \$34,255 budgeted in the operating budget for licensing, setup, support, and training.

Ordinance: Building Code and Fire Codified Updates - Staff recently reviewed the City of Vandalia Codified Ordinances and determined several sections that require amendments to reference the current Building & Fire Codes that have been adopted by the state. The Fire Code revisions are necessary due to increasing economic development, calls related to public health, and general staffing. Within the proposed amendment, Chief Follick proposes the Fire Division permit third party fire inspections with the stipulation that reports be made available to the City's Fire Code Official (Fire Chief) – as is permitted by the Ohio Fire Code. Therefore, Chief Follick is requesting an amendment, in accordance with the Ohio Fire Code, and requests that City Council authorize the proposed amendment to Vandalia Codified Ordinance 1610. The Building Code amendments primarily relate to our codified references to the Ohio Building Code. I have enclosed Mr. Cron's memorandum.

Conditional Use: Medical / Dental Office at 55 Elva Court – The Applicant, Ruben Begino, DDS, has submitted an application requesting a conditional use permit to allow the "Medical/Dental Clinics Use" on the property located at 55 Elva Ct in the Neighborhood Business (NB) Zoning District. The purpose of the request for a conditional use permit is allow for the Applicant to open a dental office at 55 Elva Ct, which was previously a medical facility without dentistry. The Applicant is seeking to occupy half of the building with his dentistry practice and rent the remaining space as medical offices. The Planning Commission voted 4-0 to recommend approval of the requested conditional use permit allowing the "Medical/Dental Clinics" use within the Neighborhood Business (NB) Zoning District.

Variance: Outdoor Storage on Stop Eight Road – The Applicant, Megan Stepansky, on behalf of White Cap, leasee of the building, has requested a variance to allow the outdoor storage area to occupy an area larger than 25 percent of the principal building's footprint. The proposal is to construct a screened outdoor storage area utilizing the outdoor area to the west and north of the approximate 45,880 sf building. The outdoor storage would utilize an area greater than 100% of the building footprint. The proposed area is approximately 51,000 sf. The Board of Zoning Appeals voted 4-0 to recommend approval of the variance to allow the outdoor storage area to occupy an area larger than 25 percent of the principal building's footprint.

#### Discussion

Vandalia Butler Chamber of Commerce 2022 Membership Level – We will discuss the desired 2022 Chamber of Commerce Membership Level. Previously Council has preferred the Platinum Level sponsorship and provided additional support during the Taste at the Crossroads Chamber event.

**Recognition of Elected Official Public Record Designee** – The State of Ohio requires elected officials to attend one accredited Public Records Training per term; or, in the alternative, select an appropriate designee to attend on their behalf. Newly elected councilmembers Vice Mayor Lewis,



Councilman Blakesly, and Councilwoman Farst have indicated a preference to designate Deputy Clerk of Council Melissa Pruszynski to attend the Public Records Training on their behalf.

### Council Meeting

#### Resolutions

- 1. Resolution 22-R-o3 Firefighter Protective Gear— The Division of Fire has a multi-year firefighter total replacement protective clothing program built into our capital budget. The goal of the replacement program is to replace ten (10) sets of protective clothing/year. \$50,000 is budgeted in 2022 for the replacement of 10 sets of firefighter protective clothing. Chief Follick is requesting that city council waive formal bidding and allow us to purchase our firefighter protective clothing from Phoenix Outfitters, an authorized, Lion Apparel dealer and a Vandalia company, as a sole source provider, at a total cost of \$33,774.00.
- 2. **Resolution 22-R-04 Police Cruiser Bids** VPD is seeking to purchase three new marked patrol vehicles to replace aging patrol vehicles. Bids for marked patrol vehicles were posted in the Daily Court Recorder and bid packets were delivered to a variety of dealerships. The City also posted the bid specifications on the city website. At the last meeting, there was some discussion about the price that was submitted by Beau Townsend Ford in comparison to the state bid price. Beau Townsend has submitted revised pricing. In consideration of the upfit and appurtenances thereto, Beau Townsend's price is 1.8% above the state bid price for the marked vehicles (\$2,184). Given the reasons outlined in Chief Althouse's enclosed memorandum, I recommend authorization to purchase the marked vehicles at a price of \$121,560, which is \$17,940 below the budgeted amount.
- 3. **Resolution 22-R-o5 Police Unmarked Car Purchase** VPD is seeking to purchase one unmarked sport utility vehicle for police administration. Bids for an unmarked sport utility vehicle were posted in the Daily Court Recorder and bid packets were delivered to a variety of dealerships. The City also posted bid specifications on the city website. One bid packet was received and opened on December 16. Beau Townsend Ford offers a 2022 Ford Interceptor Utility AWD vehicle at a revised unit price of \$43,905. City Council budgeted \$46,500.00 for this 2022 capital purchase. This price is 1.7% (\$748) above the state bid price. Given the reasons outlined in Chief Althouse's enclosed memorandum, I recommend authorization to purchase the unmarked vehicle from Beau Townsend Ford.
- 4. Resolution 22-R-o6 Flock Safety System Flock Safety devices capture objective evidence and utilize machine learning to create and to deliver unbiased investigative leads to law enforcement. A significant number of crimes occur with vehicle involvement and obtaining a license plate is often the best evidence to solve crimes. Flock Safety devices will provide leads and alert officers when a vehicle involved in criminal activity passes any location where a device is deployed. The 2022 budget includes \$30,000 to install ten Flock Safety devices at the annual cost of \$2,500/device plus a \$500 one-time installation fee. Flock Safety is the sole-source provider of such safety system. Therefore, I request that City Council waive competitive bidding and authorize me to enter into a contractual



agreement with Flock Safety for the installation and utilization of the safety equipment and software.

5. Resolution 22-R-o7 Fireworks Moratorium - In November of 2021, the State of Ohio enacted HB 172 which makes changes to the sale and use of fireworks. When HB 172 becomes effective on July 1, 2022, it will make the use of 1.4G fireworks, commonly referred to as consumer fireworks, legal on certain permitted dates including New Years Day; Chinese New Year; Cinco de Mayo; Memorial Day weekend; Juneteenth; July 3, 4, and 5; and the Friday's, Saturday's and Sunday's preceding and following Labor Day weekend; Diwali; and New Year's Eve. 1.4G fireworks include firecrackers, bottle rockets, roman candles, and fountains. Prior to the passage of HB 172, consumers could purchase these fireworks in the State of Ohio but were not permitted to discharge them. The passage of HB 172 may increase the demand for fireworks including the demand for locations to sell and manufacture these novelties, specifically 1.3G fireworks, those which may only be sold to licensed manufacturers, wholesalers, or exhibitor, and 1.4G consumer fireworks. The sale, use, and storage of fireworks is inherently dangerous. Therefore, Staff respectfully requests that City Council enact a 120-day moratorium on the manufacturing of 1.3G fireworks and the sale and discharge of 1.4G fireworks in the City of Vandalia. This moratorium period will provide Staff an opportunity to evaluate and report to Council on a recommendation dealing with the future use of 1.4G fireworks and the sale or manufacturing of 1.3G and 1.4G fireworks.

### Ordinance – Second Reading

Ordinance 22-01 to Vacate Top Notch Court Right of Way: Contegra Construction has submitted a petition and Vacation Plat to vacate the Right of Way of Top Notch Court in the Northwoods Business Park. The vacation of this right of way would accommodate the proposed development of this 35-acre site. The developer would be responsible to abandon or have relocated any and all utilities within the existing right of way before developing the property.

# **Ordinance – Emergency Reading**

**Ordinance 22-02 Assessments -** This emergency ordinance assesses properties for delinquent accounts related to storm water fees, trash collection, & sewer and water.

**Ordinance 22-03 First Amendment to Agreement** – Council recently conducted the City Manager's annual performance evaluation. This ordinance will amend the original agreement between Council and the City Manager.



#### **Reports from Boards and Commissions**

Conditional Use at 22 Ranchview Drive - The Applicant, Rick Turner, has submitted an application requesting a conditional use permit to allow the use of fuel station on the property located at 22 Ranchview Drive in the Downtown Business (DB) Zoning District. The proposal is to raze the existing fuel station and amenities to make way for the construction of a new fuel station with a modern ancillary C-store, canopy, and 4 fuel dispensers. The Applicant within their narrative statement, indicated that they are seeking to eliminate 2 out of the 4 curb cuts, the current car wash, the driveway between the C-store and residential property, yard light against the southern fence and to install a refreshed landscape. The Planning Commission voted 4-0 to recommend approval of the requested conditional use permit allowing a "fuel station" use within the Downtown Business (DB) Zoning District with the following conditions:

- 1. Complete to a minimum of 75% opacity landscape screening between adjacent residential properties and the fuel station property
- 2. Complete landscape screening of the vehicular use area from public right-of-way
- 3. Privacy fencing between the C-store and the residential properties
- 4. The base of both free-standing signs are clad in brick or stone.
- 5. A re-plat of parcels into a single parcel

Variance: Fuel Pump to Residential Line at 22 Ranchview Drive – The Applicant, Rick Turner, on behalf of True North Energy LLC, property owner, has requested a variance to allow for fuel pumps within 200' of a residential lot line. The existing fuel pumps are approximately 65' from the residential lot line and the proposal is to construct the fuel pumps 70' from the residential lot line. The Applicant, in their letter of justification states that the facility is in need of substantial upgrades and it is believed with the enhancements to the C-store, elimination of car wash and curb cuts, and refreshed and enhanced landscaping that the neighborhood would benefit and the overall character would improve. The Board of Zoning Appeals voted 3-0 to recommend approval of the requested variance to allow fuel pumps within 200 feet of a residential lot line as proposed within the site plan proposal.

Variance: Maximum Front Setback in DB zoning District at 22 Ranchview Drive - The Applicant, Rick Turner, on behalf of True North Energy LLC, property owner, has requested a variance to allow for a setback greater than 30' from the back of the sidewalk. The proposal is to construct the fuel station approximately 46' from the front of the sidewalk on the access drive to the north and approximately 120' from the property line on Ranchview Drive. The existing C-store is approximately 60' from the back of the sidewalk on the access drive and approximately 80' from the back of the sidewalk along Riverview Drive. The variance being requested is for both frontages. The Board of Zoning Appeals voted 3-0 to recommend approval of the requested variance to allow for a setback greater than 30' on both front setbacks as proposed within the site plan proposal with the follow condition being that privacy fencing is incorporated into the screening on the southern side of the property along the property line of 20 Ranchview Drive. To complete this, an additional variance for fencing within the front yard of a nonresidential property would be needed.



Variance: Minimum Setback for Fuel Stations at 22 Ranchview Drive – The Applicant, Rick Turner, on behalf of True North Energy LLC, property owner, has requested a variance to allow for a setback less than 50' from the right-of-way line. The proposal is to construct the fuel station approximately 46'from the front of the sidewalk on the access drive to the north. The existing C-store is approximately 60' from the back of the sidewalk on the access drive. The variance being requested is for the front setback to the north. The Board of Zoning Appeals voted 3-0 to recommend approval of the requested variance to allow for a 46'3" front setback on the northern side of the property.

Council Meeting Notes and Information: The TUESDAY, January 18 Study Session and City Council Meetings will be a hybrid (in-person & remote) meeting in Council Chambers. The meeting is open to Council, staff, and the public to attend in-person; however, no comments, electronic or oral, will be allowed by people that are participating electronically through Zoom. Anyone wishing to be heard on a topic will need to appear personally at the meeting. The Study Session will begin at 6:00 p.m. followed by the City Council Meeting at 7:00 p.m.

Subject: 2022 Vehicle Purchasing



As requested, the following is a comparison between the State Bid for Law Enforcement Vehicles and the bid received from Beau Townsend Ford as part of our competitive bidding process. The state bid became available on December 31, 2021. Our previous recommendation was completed on December 16, 2021.

Montrose Ford was awarded the state bid for the calendar year 2022. In reviewing the award sheet, Montrose Ford submitted pricing for the Ford Interceptor PIU. This pricing only included base features and limited upfitting and options from Ford that we currently have as specifications. I contacted Montrose Ford to get complete specification sheet pricing for all options that we receive. The lowest total price from Montrose Ford for a vehicle meeting our specifications would be \$39,792 per unit for a total cost of \$119,376.

I contacted Jeff Columbro, fleet sales with Beau Townsend Ford. I advised him of the now released state bid pricing that was not available prior to Beau Townsend's bid submission. He was able to resubmit updated pricing at \$40,520 per unit for a total cost of \$121,560. He submitted updated vehicle configurations and a signed bid tabulation form.

Beau Townsend's revised total price is \$2,184 higher than the state bid, a difference of 1.8%.

We also plan to purchase an unmarked Ford Interceptor PIU. Based on the pricing sheets sent by Montrose Ford, their total price would be \$43,157 for a vehicle meeting our specifications.

Mr. Columbro also resubmitted pricing for this vehicle at \$43,905. He submitted updated vehicle configurations and a signed bid tabulation form.

Beau Townsend's revised total price for the unmarked vehicle is \$748 higher than the state bid, a difference of 1.7%.

We have a long-standing relationship with Beau Townsend and they have proven to meet our needs and expectations. If we were to purchase vehicles on the state bid, we would be forced to work with a dealer three hours away. We have no relationship with them and are unsure if they can meet our expectations. Also, Montrose Ford will be at the mercy of recent production shortfalls in order to fulfill a large number of orders from across the state, potentially adding to delivery times. Ford is stating production is at 30 weeks currently.

I recommend we accept the revised pricing from Beau Townsend Ford for marked patrol vehicles for a total of \$121,560. City Council budgeted \$139,500 for this capital purchase. The gross purchase price is \$17,940 under budget.

I recommend we accept the revised pricing from Beau Townsend Ford for one unmarked vehicle for a total of \$43,905. City Council budgeted \$46,500 for this capital purchase. The gross purchase price is \$2,595 under budget.

Subject: Codified Ordinances update for Building & Fire Code References

Staff has reviewed the current City of Vandalia Codified Ordinances and determined that several sections require amendments to reference the current Building & Fire Codes that that have been adopted by the State.

Below is a summary of the proposed amendments. We recommend that City Council pass the appropriate legislations approving these changes to be made.

<u>Verbiage to be repealed / revised noted with strike-through. Replacement verbiage</u> is underlined and in red.

#### 874.08 SANITARY AND OTHER FACILITIES.

Each trailer park shall provide, at locations hereinafter defined, toilets, urinals, wash basins, slop sinks, showers or baths, water faucets, etc., in accordance with the following specifications:

- (a) One toilet or stool for each sex for every ten house trailer spaces or fraction thereof.
  - (b) Each toilet room provided for men shall have in addition one urinal stall.
- (c) Each toilet room having three toilets or fraction thereof shall be provided with one lavatory or wash basin.
- (d) One shower or bathtub shall be provided for each sex for each ten house trailer spaces or fraction thereof.
- (e) All toilets, showers, baths or laundry facilities shall be placed in properly constructed buildings located not more than three hundred feet from any house trailer space

- (f) Buildings shall be well lighted at all times of day and night, well ventilated with screened openings, and constructed of such moisture proof material, including well painted woodwork, as shall permit rapid and satisfactory cleaning, scouring and washing.
- (g) The floors shall be of concrete or similar material, elevated not less than four inches above ground level, and each room provided with floor drains,
- (h) Slop sinks or basins with water supply shall be provided in such number and constructed in accordance with such design, size and material as required by the City Manager, they are to be located not more than one hundred and fifty feet from each trailer space.
- (i) All plumbing installations shall be made in accordance with the requirements set forth in the Ohio Basic Building Code or the CABO One and Two Family Dwelling Code Residential Code of Ohio for One, Two and Three Family Dwellings.
- (j) Toilet facilities for men and women shall be in separate buildings at least twenty feet apart.
- (k) A cement platform of adequate and approved size, completely draining to a catch basin, shall be provided to be used for draining waste water tanks and for the washing of automobiles and house trailers. No waste water shall be discharged from any waste tanks upon the ground or any other place except on such cement platform. Each such platform shall be flushed as often as necessary to keep it clean and in a sanitary condition.

(Ord. 333. Passed 4-5-54.)

#### 1420.01 ADOPTION OF OHIO BUILDING CODE.

Pursuant to Ohio R.C. 731.231, there is hereby adopted by and for the Municipality the Ohio Building Code (OBC), being particularly the most current edition thereof, as adopted by the Ohio Board of Building Standards, Department of Industrial Relations, as published in the Ohio Administrative Code (OAC) being Chapters 4101:1-1 to 4101:1-35 of the Ohio Administrative Code being the "International Building Code 2015, first printing, Chapters 2 to 35," as published by the "International Code Council, Inc." save and except such portions thereof as may be hereinafter amended or deleted. The purpose of the Ohio Building Code is to establish minimum requirements for the erection, construction, repair, alteration and maintenance of buildings, including construction of industrialized units. Permit fees provided in Chapter 1442 of this Building and Housing Code shall be applicable to permits issued under the OBC.

#### 1424.01 CURRENT EDITION ADOPTED.

Pursuant to Ohio R.C. 731.231, there is hereby adopted by and for the Municipality the Residential Code of Ohio for One, Two and Three-Family Dwellings, being particularly the most current edition thereof, as adopted by the Ohio Board of Building Standards,

Department of Industrial Relations, as published in the Ohio Administrative Code (OAC), save and except such portions thereof as may be hereinafter amended or deleted. Being in particular, Chapters 4101:8-1 to 4101:8-25, 4101:8-29, 4101:8-34, and 4101:8-44 of the Administrative Code based upon the 2018 edition of the "International Residential Code", first printing, Chapters 2 through 24, 29, and 44 as published by the "International Code Council, Inc." including Appendix G, as promulgated by the Ohio Board of Building Standards, effective May 27, 2006. The purpose of said Residential Code is to establish minimum requirements for the erection, construction, repair, alteration and maintenance of single-family, two-family and three-family dwellings and such other structures as covered by said Residential Code.

(Ord. 05-04. Passed 2-7-05; Ord. 06-08. Passed 5-15-06.)

#### 1424.05 CONFLICT OF LAWS.

In the event of a conflict between a provision of the Residential Code of Ohio for One, Two and Three Family Dwellings, as adopted in Section 1424.01, and a provision of any other standard technical code adopted by the City, the stricter standard shall control. In the event of a conflict between any of the provisions of the Residential Code of Ohio for One, Two and Three Family Dwellings and any local ordinance, resolution, rule or regulation, the local ordinance, resolution, rule or regulation shall control. In the event of a conflict between any of the provisions of the Residential Code of Ohio for One, Two and Three Family Dwellings and a provision of State law, the provision of State law shall control.

(Ord. 05-04. Passed 2-7-05.)

\*Reason to repeal: Section 1420.07, which deals with the Ohio Building Code, was repealed by Ordinance 06-07 on 5/19/06. To repeal 1424.05 would be in the interest of uniformity since we are not permitted to adopt local ordinance which would conflict with the code adopted by the State of Ohio\*

#### 1466.01 FIRE LIMITS DEFINED.

The fire limits of the Municipality are hereby defined as the boundaries of Commercial and Industrial Zoning Districts, excluding those parcels of land located in Dayton Center Subdivision on the north side of Center Drive and which maintain a minimum building setback of 200 feet from any residential use.

#### 1482.01 ADMINISTRATION.

- (a) <u>Short Title</u>. These regulations shall be known as the Housing/Property Maintenance Code of the City of Vandalia, hereinafter referred to as "this Code."
- (b) <u>Purposes; Scope</u>. This Code is to protect the public health, safety and welfare in all existing structures, residential and nonresidential, and on all existing premises by establishing minimum requirements and standards for premises, structures, equipment, and facilities for light, ventilation, space, heating, sanitation, protection from the elements, life safety, safety from fire and other hazards, and for safe and sanitary maintenance; fixing the responsibility of owners, operators and occupants; regulating the occupancy of existing structures and premises; and providing for administration, enforcement and penalties. Additional purposes of this Code are to conserve and protect the value of premises, to protect and improve aesthetic aspects of premises and the City of Vandalia, and to provide for protection against and elimination of nuisances.
- (c) <u>Intent</u>. This Code shall be construed to secure its expressed intent, which is to ensure public health, safety and welfare insofar as they are affected by the continued occupancy and maintenance of structures and premises. Existing structures and premises that do not comply with these provisions shall be altered or repaired to provide a minimum level of health and safety as required herein.
- (d) <u>Referenced Standards</u>. The standards referenced in this Code and listed in Section <u>1482.20</u> shall be considered part of the requirements of this Code to the prescribed extent of each such reference. Where differences occur between provisions of this Code and such referenced standards, the provisions of this Code shall apply.
- (e) <u>Existing Remedies</u>. The provisions in this Code shall not be construed to abolish or impair existing remedies of the jurisdiction or its officers or agencies relating to the removal or demolition of any structure which is dangerous, unsafe and unsanitary.

- (f) <u>Workmanship</u>. All repairs, maintenance work, alterations or installations which are caused directly or indirectly by the enforcement of this Code shall be executed and installed in a workmanlike manner.
- (g) <u>Application of Other Codes</u>. Any repairs, additions or alterations to a structure, or changes of occupancy, shall be done in accordance with the procedures and provisions of the Building, Plumbing and Mechanical codes <del>and the NFPA 70</del> listed in Section 1482.20. (Ord. 00-03. Passed 5-15-00.)
