Business Appreciation Day! Thank you to all our teammates who worked to make Business Appreciation Day a success! Our team got great feedback from the business community during this event, and our employees did a great job representing our organization.



Tire Buy-Back: On Sunday, September 17, 2023, from 9:00 a.m. to 1:00 p.m. Montgomery County will hold a Tire Buy-Back event at the Montgomery County Transfer and Recycling Facility. Residents of Montgomery County are permitted to bring up to 10 tires per vehicle and will receive \$2 per tire. Please note, proof of residency is required and only passenger vehicle tires are part of the buy-back. Ordinance: Supplemental – Given that staff has presented to Council, and we have discussed each of these items previously, I am respectfully requesting that Council consider and approve the supplemental in the same meeting. Finance is requesting the approval of the following supplemental appropriation Ordinance for the following reasons:

General Fund:

Fire:

• \$55,173 – increase appropriations to cover the costs associated with the Community Risk Assessment (CRA). The Division of Fire applied for and requested an amount of \$25,000 in Federal funding back in 2021 and was awarded a grant in the amount of \$23,071.43 in April 2023. The grant award will be used to offset part of the total costs of the CRA.

Capital Improvement Plan Fund:

Parks and Recreation – Building Maintenance:

\$34,441 – increase appropriations to account for unexpected expenses for the emergency replacement
and installation of a new storm and sanitary pumping system at the Municipal Building due to a failure of
the current system.

Monday, October 2, 2023 Items:

Resolution: 2024 Part-Time Pay Plan: In November of 2022, Council approved a 2% market adjustment to the Part-Time Pay Plan for 2023. Earlier this year, the Council approved a 1% market adjustment to each position on this same pay plan in response to market conditions and internal equity (except the tipped employee positions). To attract and retain talent, and in response to market trends, staff is recommending a 3.5% increase to all part-time positions in 2024. The wage for tipped employees will be



established in accordance with the State of Ohio Department of Commerce. Approval of this new Part-Time Pay plan aligns with our 2023 Citywide Policy Goals of *Trust and Confidence* and *Opportunity*.

Resolution: 2024 General Services Pay Plan – Full Time: In November of 2022, Council approved a 2% market adjustment to the General Services Pay Plan for 2023. Earlier this year, the Council approved a 1% market adjustment to each position on this same pay plan in response to market conditions and internal equity. Staff is recommending a 3.5% increase to the top and bottom of each pay range for all full-time positions for the 2024 year. This adjustment will allow the City to continue to attract and retain high-performing, quality employees. Approval of the 2024 General Services Pay plan aligns with our 2023 Citywide Policy Goals of *Trust and Confidence* and *Opportunity*.

Ordinance: In response to the fire at the Super 8 motel, I requested that Law Director McDonald draft legislation that would allow the City of Vandalia to obtain a portion of fire insurance proceeds when there is a major loss and hold that money in a fund to be used to tear down the building (or repair it) if the owner does not. Law Director McDonald will brief Council on this matter.

Introduction and Oath of Office: Fire Marshal Scott Jacobs

City Manager Wendt will introduce and administer the Oath of Office to Fire Marshal Scott Jacobs who was promoted on September 8, 2023.

Presentation by Chris Franzmann, Partner Squire, Patton, Boggs LLP

Chris Franzmann, Partner Squire, Patton, Boggs LLP will give a presentation on Public Finance Debt Limitations.

On Monday, the City Council will hear a presentation from Mr. Chris Franzman of Squire Patton Boggs to provide Council with information regarding potential future debt service. Like Mr. Brossart, Mr. Franzman is a subject matter expert on municipal finance. Last year, Mr. Franzman presented a report to the City Council regarding the tax increment financing proposals that were adopted. I have provided some information regarding the potential impacts of debt issuance to the city below.

Resolutions

Resolution 23-R-59: Community Risk Assessment Grant -VFD- The Division of Fire has received a FEMA Fire Prevention Grant for \$23,071.43 dollars, to perform a Community Risk Assessment. This was a grant that was applied for in 2021, as a result our original (2021) inquiries and pricing has increased. The Division of Fire has completed an RFP, and our match/contribution is now \$32,101.57. The Division of Fire is requesting a supplemental appropriation to aid us in covering the cost of conducting the CRA, in late 2023.

Resolution 23-R-60: I am recommending that the City enter into an agreement with WDG Group LLC for Phase One of the Engineering and Design process for the Public Works Facility. Phase One is the programming portion of the design consisting of determining what the needs are through meetings with staff, site assessment surveys, inventory of vehicles and equipment, etc. With the programming we will develop a concept plan and proposed cost estimates for budgeting. The cost for the programming phase of the engineering and design is set at an amount not to exceed \$125,000.

Resolution 23-R-61: Professional Aquatic Staffing Service: SwimSafe Pool Management of Cincinnati has submitted a formal proposal to amend the Professional Services Agreement for Aquatic Staffing, originally dated June 18, 2020, and extended via addendums on December 9, 2021, and December 1, 2022, that would extend the term of the agreement for an additional two (2) year period, thereby changing the expiration date to December 31, 2025. The total agreement price for Cassel Hills Pool is \$144,120 for 2024 and \$148,445 for 2025. The total agreement price for the Vandalia Recreation Center pool is \$375,138 for 2024 and \$386,392 for 2025. All terms and conditions of the Agreement and Addendums are effective through December 31, 2025.

The Parks and Recreation Department completed an extensive review of SwimSafe's 2023 performance and performed a cost benefit analysis associated with providing aquatic staffing services internally. Based on the policy options, background information, cost benefit analysis and the overall analysis of the information provided we are recommending that Council approve the proposal submitted by SwimSafe Pool Management to extend the term of the Professional Services Agreement for Aquatic Staffing Services for a two (2) year period, ending December 31, 2025.

Ordinance – Emergency Reading:

(TABLED) Ordinance 23-22: Debt Issuance Schedule – This ordinance was tabled at the September 5, 2023, Council meeting for further discussion of future debt issuance proposals at the Fall Council Retreat and Council Budget meetings. The Council may or may not choose to remove this item from the table and discuss it further at the September 18th meeting. The Council may also choose or not choose to address the issue at a subsequent meeting. I have provided the Council with an updated draft estimate debt forecast.

City Council met with Mr. Andrew Brossart of Bradley Payne Advisors, the City of Vandalia's long-time municipal financial advisor, during the first budget workshop to discuss the City's bond rating score card, most recent Moody's prospectus, and how rating agencies distinguish between debt paid from general revenues (i.e., debt serviced from general revenue sources like income taxes and property taxes) and revenue debt (i.e., debt serviced from enterprise revenue sources like water and wastewater utility rates).

Mr. Brossart shared that the City's bond rating is an Aa2 with several score card ratings that fall within the AAA (the best possible) rating. Mr. Brossart emphasized the impact of general revenues being used to pay debt versus the lesser impact of debt service originating from utility revenues on the city's bond rating and corresponding interest rates for new debt.

The City of Vandalia is currently considering the Dog Leg Rd. Utility Extension Project Phase II (i.e., estimated \$4 mm maximum from utility revenues, infrastructure monies on-hand), new Public Works Facility (i.e., \$18 mm worst-case placeholder from a combination of water, sewer, storm, street, and general revenues), and Golf Course Irrigation Project (i.e., \$2 mm in general fund revenues serviced through the Golf Fund). There are smaller utility-related projects that could result in interest free OPWC or other similar loans that should not have a large impact on the City's general obligation bond rating because they are directly tied to utility provision.

Mr. Brossart also indicated that because Tri-Cities is its own standalone government entity, it has its own bond rating, which does not directly affect the city's general obligation bond rating. Debt service for the plant improvements at Tri-Cities is not anticipated until approximately 2030. Staff has included placeholders in the preceding years to be conservative.

Regarding the utility extension project, the amortization schedule for a 20-year bond at an interest rate of 4.5% for a \$4 mm principal results in the city paying \$2,148,075 in interest with a total 20-year debt service totaling \$6,148,075 at the City's current Aa2 rating.

Although unlikely given this proposal and the City's bond score card, Mr. Brossart shared that if the City were to be downgraded to the rating to Aa3, the City would experience interest rate increases of approximately 0.05% above the current rating on future debt issuance. Mr. Brossart noted that current debt issuance would not be impacted. For the current proposal, a hypothetical down grade to the Aa3 rating would result in an amortization schedule for a 20-year bond at an interest rate of approximately

4.55% for a \$4 mm principal resulting in the city paying approximately \$2,175,477 in interest with a total 20-year debt service totaling approximately \$6,175,477 – a difference of approximately \$27,402 over 20 years (or an approximate average of \$1,370.10 per year) more than the current Aa2 rating.

Mr. Brossart shared that if the City were to be downgraded two ranks to the rating to A1, unlikely given this proposal, the City would experience an interest rate increase of an additional 0.15% (i.e., a total increase of 0.20% from the current rating of Aa2) on future debt issuance and noted that current debt issuance would not be impacted. For the current proposal, a hypothetical down grade to the A1 rating would result in an amortization schedule for a 20-year bond at an interest rate of approximately 4.70% for a \$4 mm principal resulting in the city paying approximately \$2,256,500 in interest with a total 20-year debt service totaling approximately \$6,256,500 – a difference of approximately \$108,425 over 20 years (or an approximate average of \$5,421.25 per year) more than the current Aa2 rating.

This exercise can also be performed against the amortization schedule for a potential public works facility with an estimated worst-case scenario of \$18 mm (depending on programming and the forthcoming needs assessment).

The amortization schedule for a 20-year bond at an interest rate of 4.5% for a \$18 mm principal results in the city paying \$9,675,900 in interest with a total 20-year debt service totaling \$27,675,900 at the City's current Aa2 rating. Unlike the utility extension project, the public works facility project debt service forecast includes approximately 15% of debt service payments (~\$210,000 / yr.) from general revenue sources (i.e., payments from facilities improvement fund 360, which is financed from general fund 110), as well as the street fund, stormwater fund, water fund, and sewer fund.

Assuming the City were to be downgraded to the rating to Aa3, the City would experience interest rate increases of approximately 0.05% above the current rating on future debt issuance, and current debt issuance would not be impacted. For the public works facility proposal, a hypothetical down grade to the Aa3 rating would result in an amortization schedule for a 20-year bond at an interest rate of approximately 4.55% for an \$18 mm principal resulting in the city paying approximately \$9,797,205 in interest with a total 20-year debt service totaling approximately \$27,797,205 – a difference of approximately \$121,305 over 20 years (or an approximate average of \$6,065.25 per year) more than the current Aa2 rating.

Assuming the City were to be downgraded two ranks to the rating to A1, the City would experience an interest rate increase of an additional 0.15% (i.e., a total increase of 0.20% from the current rating of Aa2) on future debt issuance, with current debt issuance being unimpacted. For the public works facility proposal, a hypothetical down grade to the A1 rating would result in an amortization schedule for a 20-year bond at an interest rate of approximately 4.70% for a \$18 mm principal resulting in the city paying approximately \$10,162,086 in interest with a total 20-year debt service totaling approximately \$28,162,086 – a difference of approximately \$486,186 over 20 years (or an approximate average of \$24,309.30 per year) more than the current Aa2 rating.

On Monday, the City Council will hear a presentation from Mr. Chris Franzman of Squire Patton Boggs to provide Council with information regarding potential future debt service. Like Mr. Brossart, Mr. Franzman is a subject matter expert on municipal finance. Last year, Mr. Franzman presented a report to the City Council regarding the tax increment financing proposals that were adopted.

The purpose of this tabled ordinance is to provide for the issuance and sale of bonds in the maximum principal amount of \$6,000,000 for the purpose of paying the costs of improving the municipal public transportation system, including National Road (US-40) and Dog Leg Road, by constructing, reconstructing, extending, opening, widening, grading, draining, curbing, paving and resurfacing, and site preparation, installing storm water, sanitary sewer and water improvements, and acquiring any necessary interests in real property, together with all incidental work and related appurtenances thereto, and declaring an emergency. Although the legislation states that the issuance is not to exceed \$6 mm, Director Cron has worked with Choice One Engineers to reduce costs by reducing the amount of pavement and restoration that will need to be conducted on US-40. As a result, the engineer's estimate is approximately \$3.1 mm and our team believes that with contingencies, the City will not need to issue debt of more than \$4 mm for the project. Debt service for this project will likely be paid from water and wastewater utility revenues, infrastructure fees, and possibly tax increment financing associated with development in the future. This project is not likely to result in direct general fund expenditures and per Mr. Brossart, will not impact our general obligation debt scores, which relate to

our overall bond rating.





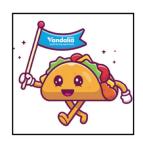
