Passport to Safety Program: Sergeant Andy Wehner and Officer Rich Sommer finished the 2023 Passport to Safety Program on September 15 with St. Christopher kindergartners. This year's program successfully graduated 239 students; Helke – 107, Demmitt - 88, St. Chris - 44. Passport to Safety continues to be a successful program in the community with over 40 years of continuance. Not only are safe practices taught to the students, but it's also a wonderful opportunity to build positive relationships between students and first responders at a young age.

Playground Safety Inspector: Recreation Superintendent Rudy Wells attended the Certified Playground Safety Inspector Course in Dublin last week. This course is supported by the National Recreation and Parks Association and is important for our department to have someone trained in the inspections and regulations of playground systems. The City's playgrounds are inspected regularly.

Solar powered trash compactors! The parks maintenance team has started the installation process for the solar powered trash compacting units (separate units for trash and recycling) and a solar powered charging bank for handheld electronics at the Art Park. Staff will be removing soil and installing a concrete pad for these units.

Sports Complex Playground Installation! The Sports Complex Playground "Play In" Ribbon Cutting Event will be scheduled for a Saturday in October with a date being finalized once the project is close to being finished.





Commercial Truck Traffic: During the past two weeks, VPD officers made 17 traffic stops on commercial motor vehicles for traffic violations. These stops resulted in two traffic citations, 14 written warnings and one verbal warning while working 16 additional enforcement hours.

Lobbying Against Bigger Trucks: On September 12, Chief Althouse participated in a fly-in to Washington, D.C. to partner with a non-profit group, Coalition Against Bigger Trucks (CABT). On September 13, he visited the offices of 12 U.S. Representatives and Senators from Ohio to communicate our opposition to three federal legislative bills that would permit states to increase the

size and weight of commercial vehicles on public roadways. Chief Althouse expressed the safety concerns and potential infrastructure damage that could result from bigger and heavier trucks in Vandalia and across Ohio.

Joint Motor Vehicle Enforcement Detail: On September 19, VPD worked a joint commercial motor vehicle enforcement detail with Ohio State Highway Patrol (OSP) and a couple of their Motor Carrier Enforcement Inspectors (MCE). The specific troopers who we work with, as well as the MCE units, have advanced training in commercial motor vehicle enforcement, which allows them to inspect and issue citations for administrative violations. Our goal is to work one of these joint details each month.



Truck Traffic Counts: DES has received all of the data from the latest traffic counts performed during the last week of August. City Engineer Ben Borton is evaluating the data and preparing a presentation to compare the two previous counts. At first glance it appears our new signage and enforcement efforts are making a difference.

Thru Truck Traffic Legislative Prohibition: The City and High Bridge Co. have been working with Senator Huffman's office and the Legislative Services Commission to draft appropriate legislation to authorize the City to prohibit thru truck traffic on US-40 in Vandalia. The City is working with the LSC and our partners to shore up language and hope to work with our elected officials to get this legislation introduced in Columbus.

Hotel Permitting Program: On September 14, Lieutenant Walker, VFD Chief Follick, Fire Marshall Scott Jacobs, Pete Baldauf, and Jerry McDonald, met with Miamisburg officials regarding our hotel program. They have seen the success of our enforcement efforts and are interested in adopting some of our practices to combat problems they are having with hotels in their community.



Sanitary Sewer Replacement at I-75 / National Rd.: CG Construction & Utilities has completed the sanitary sewer replacement at I-75 and National Road. They will be completing the final restoration of the reject in the next week or so. This project was the result of a collapse in the existing line last winter. The old concrete main has been in place since1953. Temporary repairs were made at that time until the engineering could be completed, and a permit obtained from ODOT to perform the work in their right of way.


Sanitary Sewer Slip Lining bids will be opened next week. Director Cron will present the bid results at the City Council Study Session on October 2nd. We were awarded \$50,000 in Community Development Block Grant funds towards this project.

Four **Rapid Flashing Beacons** have been installed and are working. The devices were installed at the crosswalks at Demmitt and Helke Elementary Schools, the new crosswalk on East Alkaline Springs at Butler High School, the Vandalia Art Park, and the crosswalk on Stonequarry Road from the Copperfield subdivision to the Sports Complex.

Water Meter Replacement: The City learned that a recent order for water meters that were scheduled to arrive in December will arrive next week. Public Works was down to our last 25 meters on hand and will begin to install the next 1,000 smart meters.

Variable Message Boards: Public Works will be setting up our message boards in advance of Butler High Schools homecoming parade to notify drivers of the event.

Leaf Collection Preparation: Mechanics Mike Skaggs and Zeb Ward have been preparing our leaf collection equipment for the upcoming season. Enclosed is the schedule and map for leaf collection this year. More information is available at: www.vandaliaohio.org/leaf

- Kristen and I attended a council study session and meeting. I presented the Department of Finance Update, August 31, 2023 YTD financials and supplemental appropriation request.
- Kristen and I met with representatives from PNC Bank to discuss the City's investment accounts and future cost saving treasury management programs and options available to the City.
- 3. Lattended the Fall Council retreat.
- 4. Kristen and I attended the Council Budget workshops.
- 5. Rob Cron and I met with bond counsel to discuss various financing options available to the City.
- 6. I attended a <u>Tri-Cities Finance Committee</u> meeting. I presented the August 31, 2023 YTD financials:

Year to date (2023) Revenues for sewer service are up 2.28% from 2022 (factoring out the one-time assessment in 2022.) Interest revenue is up YTD 2022. Refund/Reimbursement Revenues are down due to Meijer Dairy stipulated penalties revenue received in 2022. Revenue was also received from miscellaneous revenue.

Year to date (2023) Expenses (which includes Operating & Maintenance, Capital and Debt service payments) are up 27.85% from 2022 due to timing and the explanations below.

Explanations for differences in expense amounts from 2023 vs 2022:

General Fund:

- 1. Rents & Leases increase due to TCA Farm Lease
- 2. Legal Services decrease due to wastewater regulatory counseling cost, and Ohio ethics commission investigation costs paid in 2022
- 3. Other Professional Services increase due to increase in O&M Fees paid to Veolia Water, and 2022 financial audit costs
- 4. Repairs and Maintenance decrease due to 2022 final clarifier repairs, and tree trimming
- 5. Facility Maintenance increase due to clarifier pump reimbursement and mowing services
- 6. Insurance increase due to increase in liability insurance paid to Public Entities Pool
- 7. Improvements increase due to lab cabinet painting, plant upgrade study, and project design and engineering costs paid to Hazen & Sawyer
- 8. OWDA Loan Payments decrease due to decrease in loan principal from loan payoff

Capital Improvement Fund:

- 1. Consultant services decrease due to 2022 disinfection chemical cost
- 2. Other Professional Services decrease due to 2022 disinfection chemical cost, and new office printer/scanner, and annual service fees
- 3. Building/Land Improvements increase due to sewer lining project

Budget:

Revenues

YTD actual sewer service revenue collected was 61.99% of the budgeted amount, and YTD actual interest revenue collected was 247.04% of the budgeted amount.

Expenses (General Fund)

YTD actual expenses were 72.23% of the budgeted amount partly due to timing, and the explanations referenced above.

Expenses (Capital Improvement Fund)

YTD actual expenses were only 4.44% of the budgeted amount partly due to timing, and the explanations references above.

- League play has started winding down for the season. A few leagues will be having a end of season party at the Clubhouse. Several leagues will continue play through the end of September.
- We experienced several irrigation system malfunctions over the past week with Marty and Tim working to keep the system in working order.

SENIOR CITIZENS CENTER

- Exercise bands have been purchased for senior exercise classes at the Senior Center, replacing bands that have been in place for over 8 years. Participants are grateful for the new exercise equipment.
- o Jeff Kreill and Toni Williams treated Van Tran volunteers to a lunch at Olive Garden earlier this week. The annual luncheon is a small token of appreciation to the donated time of the drivers for the program.
- o It has been a busy month for memberships at the Senior Center as 19 new members have joined in September bringing the membership total to just under 700.

FACILITY MAINTENANCE DIVISION

- O Helke Park playground installation is complete and the safety surface contractor will complete installation of the Forever Lawn Playground Grass by the end of this week (see pictures). Playground equipment installers have moved to the Sports Complex and plan to have the unit installed by early next week with safety surface installation to follow mid-week. Park Staff installed approximately 450 feet of drainage under the area of the play unit and is currently improving the grade outside the play area, so grass seed can be spread.
- O Rudy Wells attended the Certified Playground Safety Inspector Course in Dublin last week. This course is supported by the National Recreation and Parks Association and is important for our department to have someone trained in the inspections and regulations of playground systems. Test results will be shared in four to six weeks.
- Maintenance staff has been working in conjunction with the playground installs at Helke Park and the Sports Complex. They have aided with site preparation, underground drainage pipe installation and grade modifications (as needed) to the ground surrounding the new play areas.
- ESG Facilities Infrastructure work continues with the install of the flat roof at the Justice Center and controls and operational items at the Recreation Center, Justice Center, Municipal Building and Senior Center.
- Rudy and staff have completed review of deign drawings for The Robinette Park restroom building. OHM is now making the necessary changes to the specifications and will have the document ready for bid in the coming weeks.
- Maintenance staff have started the installation process for the solar powered trash compacting units (separate
 units for trash and recycling) and a solar powered charging bank for handheld electronics at the Art Park.
 Staff will be removing soil and installing a concrete pad for these units.

- Watering of trees and young landscape plants as needed due to dry soil conditions. We have also been watering newly planted grass seed in the areas of the new play structure locations in hopes of good stand of grass prior to the opening of these playgrounds.
- o Rudy met with a local Eagle Scout candidate regarding a late fall tree planting project that is being planned for the Sports Complex.

- 1. During the past two weeks, VPD officers made 17 traffic stops on commercial motor vehicles for traffic violations. These stops resulted in two traffic citations, 14 written warnings and one verbal warning while working 16 additional enforcement hours.
- 2. Detectives charged a Vandalia man with Domestic Violence as a result of an investigation involving a 10-year-old victim being abused by his father which was reported to VPD via Smith Middle School.
- 3. Sergeant Andy Wehner and Officer Rich Sommer finished the 2023 Passport to Safety Program on September 15 with St. Christopher kindergartners. This year's program successfully graduated 239 students; Helke 107, Demmitt 88, St. Chris 44. Passport to Safety continues to be a successful program in the community with over 40 years of continuance. Not only are safe practices taught to the students, but it's also a wonderful opportunity to build positive relationships between students and first responders at a young age.
- 4. On September 11, I attended the Oath of Office for the new Dayton International Airport Police Chief, Daryl Wilson, held at the Dayton Municipal Building. Chief Wilson retired earlier this year as the Chief Deputy of Montgomery County Sheriff's Office and is a long-time colleague of mine. We look forward to continuing a positive partnership with the Dayton Airport Police.
- 5. I appreciate the opportunity to attend Council's Fall Retreat workshop on September 11 where we discussed the future opportunities for our community and projects in the works.
- 6. On September 12, I attended the grand opening of the new Wright-Patt Credit Union branch on Benchwood Road. We welcome WPCU to Vandalia and enjoyed participating in their ribbon-cutting ceremony on behalf of the City.
- 7. On September 12, I participated in a fly-in to Washington, D.C. to partner with a non-profit group, Coalition Against Bigger Trucks (CABT). On September 13, we visited the offices of 12 U.S. Representatives and Senators from Ohio to communicate our opposition to three federal legislative bills that would permit states to increase the size and weight of commercial vehicles on public roadways. I expressed the safety concerns and potential infrastructure damage that could result from bigger and heavier trucks in Vandalia and across Ohio.

- 8. On September 14, Lieutenant Walker, VFD Chief Follick, Fire Marshall Scott Jacobs, Pete Baldauf, and Jerry McDonald, met with Miamisburg officials regarding our hotel program. They have seen the success of our enforcement efforts and are interested in adopting some of our practices to combat problems they are having with hotels in their community.
- 9. Lieutenant Walker and Sergeant Flynn met with Public Works on September 15 to work on traffic control planning for the upcoming Butler High School Homecoming Parade. The parade is scheduled for Thursday, September 28, and will begin at 5:45 p.m. The route begins on West National Road at Helke Road and continues to South Dixie Drive where it ends at the high school. The route extends down Dixie Drive to East Alkaline Springs Road to keep the roadway safe as students are picked up by parents at the First Light Baptist Church Hangar.
- 10. Detectives charged a 33-year-old Vandalia man for Theft and Forgery. The suspect stole and used a credit card without the owner's consent. The suspect also stole and cashed a check without the owner's consent.
- 11. Detectives charged a 33-year-old Vandalia man for Burglary and Disruption of Public Services. The suspect forcefully entered a residence without permission and took the victim's cell phone. Suspect was apprehended in a nearby woods by Vandalia officers and transported to the Montgomery County Jail.
- 12. Last Saturday, I attended a Miami Valley Community ID Card Program held at Christian Life Center where they hosted a gathering of immigrants who registered to receive a local identification card which assists them in daily interactions. This program is open to all immigrants with most predominantly from the Hispanic and Latino communities. It was an honor to welcome them and encourage them as they seek their U.S. citizenship.
- 13. We want to thank Vandalia Church of the Nazarene for hosting a First Responder Service and Hog Roast on September 17 at their Sunday service. Pastor Mark Batton welcomed the first responders who attended, and I was able to greet the congregation on behalf of VPD. Clearcreek Twp. Police Officer Eric Ney shared his miraculous story of surviving his shooting incident last summer. Several VPD officers and firefighters enjoyed a great luncheon with the church members following the service. Pastor Batton is a VPD chaplain and provides a great service to our community.
- 14. I appreciate the opportunity to have shared VPD's 2024 budget to City Council and the city manager staff last Monday during budget presentations in the Community Room.
- 15. On September 19, VPD worked a joint commercial motor vehicle enforcement detail with Ohio State Highway Patrol (OSP) and a couple of their Motor Carrier Enforcement Inspectors (MCE). The specific troopers who we work with, as well as the MCE units, have advanced training in commercial motor vehicle enforcement, which allows them to inspect and issue citations for administrative violations. Our goal is to work one of these joint details each month.

- 16. We held detective interviews on Wednesday, September 20, and Thursday, September 21. Four candidates applied to fill the detective position vacancy created by Brian Krimm's promotion to sergeant.
- 17. On September 20, I attended the quarterly virtual meeting for the R.A.N.G.E. Task Force Executive Board and Collaboration Board. I also attended the virtual District 4 meeting for the Ohio Association of Chiefs of Police (OACP).
- 18. Several VPD employees attended the recent Employee Appreciation Taco Bar at the Senior Citizen Center this Wednesday and enjoyed interacting with other city employees while enjoying a fiesta lunch. We thank the City for offering these lunches throughout the year.
- 19. Detectives charged a 37-year-old Dayton man for Improper Handling of a Firearm in a motor vehicle. Suspect was operating a motor vehicle while under the influence of alcohol and a loaded firearm was located on the floorboard of the driver's seat. The suspect was incarcerated in the Montgomery County Jail.
- 20. A few weeks ago, we began receiving complaints about possible homeless individuals squatting on the vacant property just south of Red Robin and LongHorn Steakhouse, owned by the Drury Development Corporation. The property has some overgrowth that provides seclusion and it is difficult to see from surrounding parking lots or the roadway. We discovered homeless individuals living on the property. Officers tried several solutions to resolve the issue, including our mobile CIT clinician who offered them emergency housing options. Ultimately, the Drury Development Corporation provided us with a trespass letter authorizing our officers to trespass anyone found on the property. On September 20, officers walked the property to remove any individuals living there. VFD assisted by using the drone to help search the property. With the property now clear, we are working with Drury Development Corporation on property maintenance issues to clean up the site and prevent similar problems in the future.
- 21. I attended a virtual meeting for the Sinclair Community College Criminal Justice Advisory Board on Thursday to review recent activities in the police academies and criminal justice programs at the campus. We appreciate the partnership with Sinclair and would note that VPD's two most recent police officers were Sinclair police academy recruits.
- 22. On Friday, I participated in second round interviews with you for several police officer applicants.

Development & Engineering Services

CG Construction & Utilities has completed the sanitary sewer replacement at I-75 and National Road. They will be completing the final restoration of the reject in the next week or so. This project was the result of a collapse in the existing line last winter. The old concrete main has been in place since 1953. Temporary repairs were made at that time until the engineering could be completed, and a permit obtained from ODOT to perform the work in their right of way.

We will open bids for our Sanitary Sewer Slip Lining project next week and will present the bid results at the City Council Study Session on October 2nd. We were awarded \$50,000 in Community Development Block Grant funds towards this project.

We have received all of the data from the latest traffic counts performed during the last week of August. Ben Borton is evaluating the data and preparing a presentation to compare the two previous counts. At first glance it appears our new signage and enforcement efforts is making a difference.

Chad Baughman and Ben Borton have performed an evaluation and rating of all our roadways and updated our ten year resurfacing forecast. We try to re-evaluate every other year as conditions change and to coordinate with other projects that may be coming up. Our goal is to have our concrete and resurfacing projects out for bid earlier next year.

Our consultant continues to work on the right of way acquisition for the Bikeway project. To date we have signed documents from four of the eight property owners. One of the outstanding properties is CSX. They are in support of the project but there is a separate process to acquire an aerial easement from them for the bridge over the railroad property.

We have received, for review, stage one plans for the NE Logistics Access project that would improve Northwoods Blvd., N. Dixie Dr. and Lightner Road. We are partnering with the Montgomery County Engineer's office for this project.

The permit was released for a 3,000sf accessory structure for Waibel Energy Systems at 811 Falls Creek Drive.

A permit has also been released for a 2,376sf addition for Central Transport at 11040 N. Dixie Drive.

A temporary Certificate of Occupancy has been issued for Kroger "Click List" at 78 Northwoods Boulevard.

Thank you for the opportunity to attend the City Council retreat and several budget workshops. It is very helpful to hear the visions and goals of our elected officials as we prioritize our funding and resources for upcoming projects and ongoing maintenance of our infrastructure.

Ben Borton and Jake Hayslett attended the Tri Cities Technical Committee Meeting on Wednesday September 13th.

Robert Martin and I participated in the Business Appreciation Day Golf outing on September 12th. It was a great day for networking with our local business community. Thanks to the Cassel Hills staff for hosting a great event.

Public Works

The four Rapid Flashing Beacons have been installed and are working. The devices were installed at the crosswalks at Demmitt and Helke Elementary Schools, the new crosswalk on East Alkaline Springs at Butler High School, the Vandalia Art Park, and the crosswalk on Stonequarry Road from the Copperfield subdivision to the Sports Complex.

We continue with our scheduled water meter replacements. We are down to our last 25 meters that we have on hand. We did receive great news this week. The 1,000 meters on order that were previously scheduled for delivery in December are now scheduled to be delivered next week.

We performed utility shut offs during this period for delinquent customers. There we 49 customers on the list this month.

Crews are replacing a fire hydrant that was struck by a hit and run driver at the intersection of Cassel Road and Old Springfield Road.

We have completed the EPA required water valve exercising in zone quadrant 2 of our system. We must exercise 20% of our 2,100 valves each year.

We will be setting up our message boards in advance of Butler High Schools homecoming parade to notify drivers of the event.

Mechanics, Mike Skaggs and Zeb Ward have been preparing our leaf collection equipment for the upcoming season. Attached is the schedule for leaf collection this year.

The new fall banners highlighting a photo of Cassel Hills Golf Course were installed on National Road.

We performed two burials at Poplar Hill Cemetery during this period.


We continue with our right of way mowing and spraying of vegetation.


We responded to a total of 144 utility locates to date in September.



DIVISION OF POLICE

The Vandalia Division of Police prides itself on being in touch with the community and providing exceptional customer service. The Vandalia Division of Police headquarters is located at 245 James Bohanan Drive in the Vandalia Justice Center. The Vandalia Division of Police operates an award-winning communications center, which the community has come to rely on for fast, professional and courteous service.

The Vandalia Division of Police is one of a small number of Ohio police agencies accredited by The Commission on Accreditation for Law Enforcement Agencies.

The Division of Police has as its mission the protection of life and property and the promotion of a safe and secure environment, in a manner that is consistent with community expectations. Mission achievement strategies include: Crime Prevention and Suppression; Order Maintenance; Detection and Apprehension of Law Violators; Recovery of Lost and Stolen Property; Promotion of Community Support, Cooperation and Goodwill.

The Vandalia Division of Police is dedicated to effective and efficient operation; fair and impartial application of laws; courteous, professional and ethical conduct; and the professional development of its personnel. Vandalia police personnel shall respect and protect the rights of individuals and perform their services with honesty, zeal, courage, discretion, fidelity, competency, and sound judgment.


and attention to detail

Must possess a valid State of Ohio driver's license and must remain insurable under the City's vehicle insurance plan; Emergency Medical Dispatch Certification and LEADS Certification.

ESSENTIAL FUNCTIONS OF THE POSITION



PSS are a calming influence, on the phone or radio, when citizens or safety personnel are faced with dangerous and life-threatening situations. PSS are one of the most critical parts of public safety.



PSS provide fast and reliable information to officers in the field. They are the lifeline in high-stress situations, and give proper information to ensure the safety of officers and the public.



PSS are trained in Emergency Medical Dispatching. They have the ability to provide life-saving instruction over the phone to citizens, in order to assist patients and provide EMS with critical information prior to arrival. These duties can be the difference between life and death.



PSS are the core of VPD's record keeping function. They are responsible for internal and external record management as well as fulfilling the needs of the public to ensure transparency and legal obligations.



PSS are proficient in the use of modern technology and equipment, allowing them to quickly assess the needs of the public and safety personnel. This ensures proper use of resources to meet the needs of the community we serve.

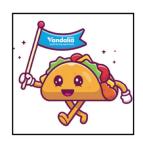


