### **RESOLUTION 18-R-66**

### **ORDINANCE 18-22**

#### **AN ORDINANCE REZONING THE PROPERTY GENERALLY LOCATED AT THE NORTHWEST CORNER OF MILLER LANE AND STOP EIGHT ROAD FROM RESIDENTIAL SINGLE-FAMILY 1 “RSF-1” TO HIGHWAY BUSINESS “HB” AND AMENDING THE ZONING MAP OF THE CITY**

The ordinance, which bears the foregoing title was unanimously approved in its first reading Monday, October 15, 2018, by the Council of the City of Vandalia. It rezones the property generally located at the northwest corner of Miller Lane and Stop Eight Road from Residential Single-Family 1 “RSF-1” to Highway Business “HB” and amending the zoning map of the city. The proposed ordinance will be considered for final adoption by the Council of the City of Vandalia, Ohio on Monday, November 5, 2018 at 7:00 p.m., in Council Chambers, 333 J.E.
