

**CONCRETE INSTALLERS BOND**

KNOW ALL MEN BY THESE PRESENTS: THAT WE \_\_\_\_\_

THE CONDITION of the obligation is such, that whereas on the \_\_\_\_\_ day of \_\_\_\_\_ 20\_\_\_\_, the said \_\_\_\_\_ was under the authority of Law duly issued a permit by the City of Vandalia for installation of concrete sidewalks, curbs, and/or drives within said City.

NOW, if the said \_\_\_\_\_ in the building of concrete sidewalks, curbs, drives being issued permits to do so by the City of Vandalia, and having contracted therefore, whether with said City or a property owner, shall conform strictly to all the requirements of law including the ordinances of said City applicable thereto, shall construct all such sidewalks, curbs, drives according to established grade, and in accord with specifications adopted by said City or any official thereof authorized in the premises, shall remove all debris after the completion of any sidewalk, curb, drives or portion thereof for which he has contracted; shall pay all damages which may accrue because of any defective or inferior workmanship or materials in any sidewalk, curb, drives which he may construct or shall repair or replace same provided such defective condition becomes evident before the end of the guarantee period provided in the contract for the construction of such sidewalks, curbs, drives, and shall indemnify and save harmless the City of Vandalia and the property owner with whom he may contract for the building of sidewalks, curbs, drives either or both of them, from all claims, charges, losses, costs, damages, suits and actions of every kind brought against either or both, for or on account of any injury or damage to persons or property, or both because of, arising out of, or incident to the construction of the work in any such contract specified to be done, or the doing of any work therein described, and shall pay any and all legal claims for labor, material, machinery or equipment furnished for the work specified in any such contract, then these presents shall be void. Otherwise to remain in full force and effect through the period ending on the \_\_\_ day of \_\_\_\_\_, 20\_\_\_\_.
