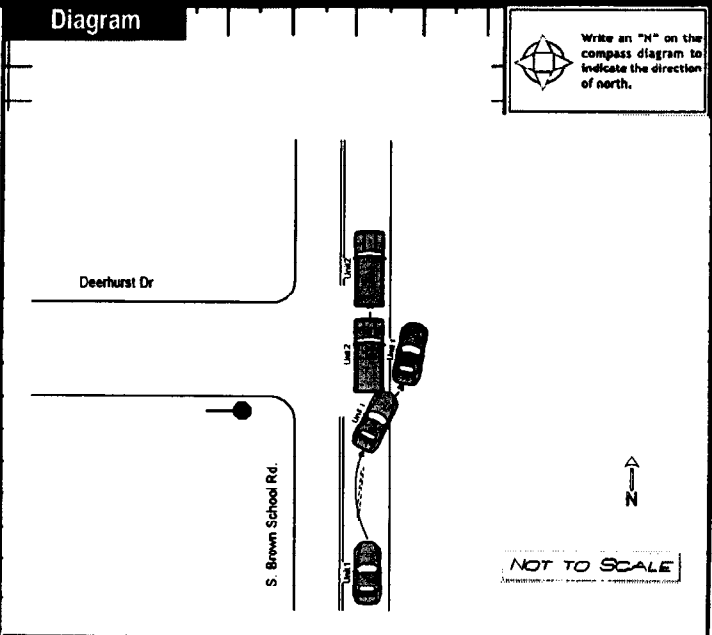

Unit 2 stopped to make a left turn to go west onto Deerhurst Dr. Driver of Unit 1 failed to bring his vehicle to a stop and attempted to swerve to the right to avoid striking Unit 2 but was unable to avoid a collision striking Unit 2 in the right rear with his left front. Both vehicles were disabled due to the collision. Both drivers refused a medic response.



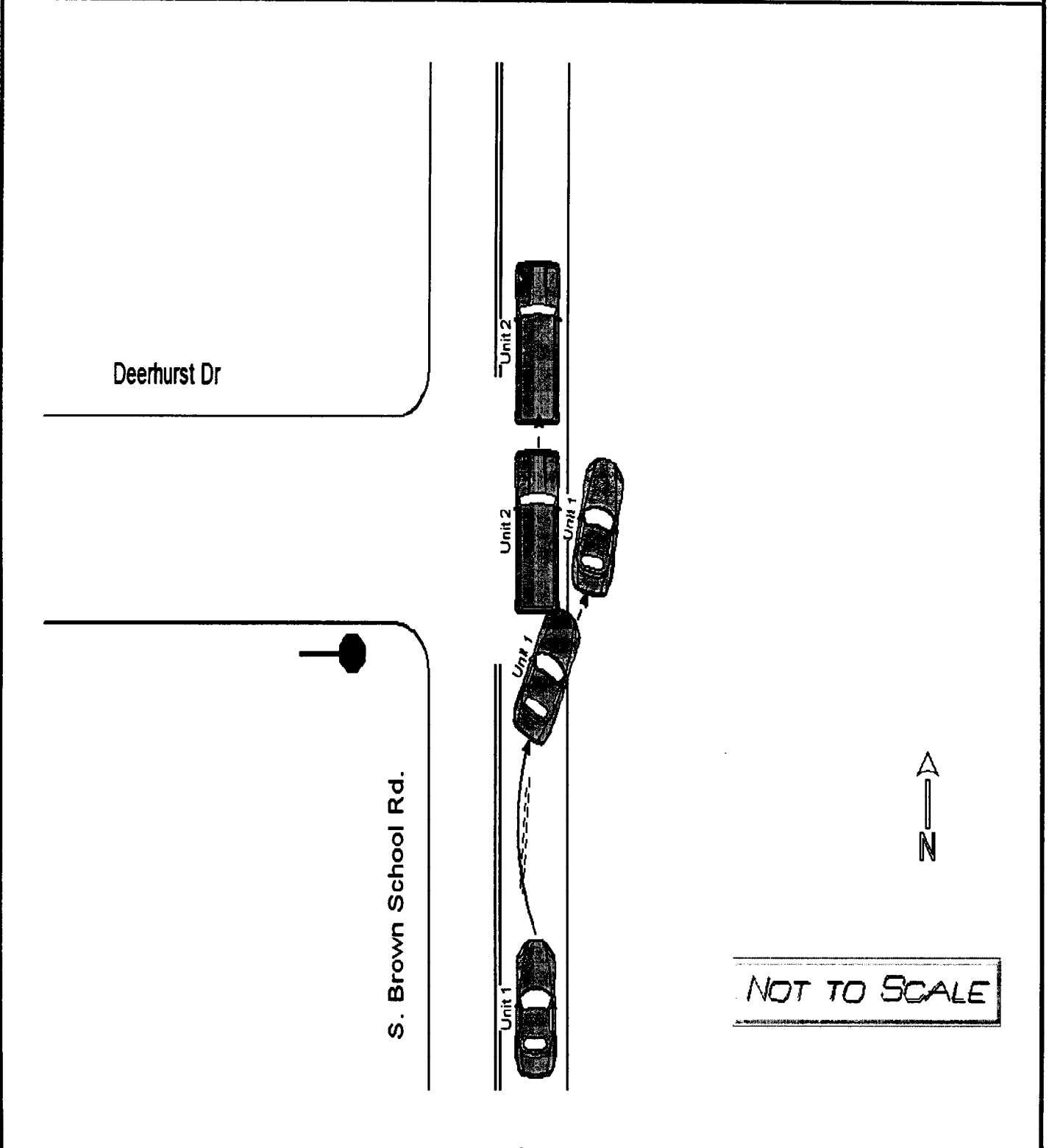
