**REFERRAL TO DISTRACTED DRIVING PROGRAM**

Defendant agrees to waive their right to trial and enter a Guilty Plea to the underlying offense charged and a conditional guilty plea to the enhanced charge of distracted driving. Defendant has been referred to the Distracted Driving Program (DDP) and the sentence has been stayed. Defendant must pay the \$140.00 non-refundable fee before participating in the program. **MONEY ORDER ONLY MADE PAYABLE TO VANDALIA MUNICIPAL COURT. NO PERSONAL CHECKS WILL BE ACCEPTED.**

Defendant must pay a \$140.00 DDP non-refundable fee and complete the scheduled DDP class within 30 days of payment of the program fee.

**EFFECT OF THE DISTRACTED DRIVING PROGRAM**

**Successful completion:** Defendant's Guilty Plea to the underlying charge will be processed without the additional distracted driving fine of \$100.00.

**Unsuccessful completion:** An additional \$100.00 fine will be assessed. Defendant's conviction will be forwarded to the Ohio Bureau of Motor Vehicles, where points may be added to Defendant's driving record. The \$140.00 for the underlying offense will be forfeited. Any unpaid fine for distracted driving enhancement will be sent to collection and a warrant block will be placed on Defendant's driving record with fees assessed.

**By signing below, Defendant Agrees to Participate in the Distracted Driving Program and Understands:**

- (1) The requirements of the Distracted Driving Program, the Referral and the effects of successfully completing or unsuccessfully completing the Distracted Driving Program.
- (2) The \$140.00 Distracted Driving Program **non-refundable fee** must be paid before attending the distracted driving safety course. **MONEY ORDER ONLY MADE PAYABLE TO VANDALIA MUNICIPAL COURT. NO PERSONAL CHECKS WILL BE ACCEPTED.**
- (3) Defendant is not relieved from the responsibility of paying additional fines and costs as assessed by the waiver bureau if the defendant fails to complete the Distracted Driving Program.

**DISTRACTED DRIVING PROGRAM ENTRY**

The Defendant knowingly, intelligently and voluntarily enters a Plea of Guilty, waives their right to trial, and is hereby **sentenced to a fine, court costs and any fees as set by the waiver bureau.** Defendant's case is referred to the Distracted Driving Program, the Defendant voluntarily agrees to participate in the Distracted Driving Program and the Defendant's sentence is hereby stayed.

**The Court Orders:**

- (1) Defendant shall pay all fees and the \$140.00 DDP fee within 30 days of this Entry;
- (2) Defendant shall complete the DDP class within 30 days of payment of the program fee;
- (3) The \$140.00 fee is non-refundable and no continuances shall be granted.

**The Court Further Orders:**

**Successful completion:** Defendant's Guilty Plea to the underlying charge will be processed without the additional distracted driving fine of \$100.00.

**Unsuccessful completion:** An additional \$100.00 fine will be assessed. Defendant's conviction will be forwarded to the Ohio Bureau of Motor Vehicles, where points may be added to Defendant's driving record. The \$140.00 for the underlying offense will be forfeited. Any unpaid fine for distracted driving enhancement will be sent to collection and a warrant block will be placed on Defendant's driving record with fees assessed.
